## **A CALL TO AMERICAN PATRIOTS!**

American Patriots! Do not let yourselves be controlled!

Take the lead! Make Demands! Sound the call!

On Wednesday, May 4, 2011, CBS reporter Steve Kroft interviewed Barack Hussein Obama concerning the decision to conduct the mission to kill Osama bin Laden. The interview was televised on *60 Minutes* on Sunday, May 8, 2011. Anyone watching the program must come to the conclusion that before the interview began, reporter Steve Kroft's questions were phrased in advance, censored, and selected by Barack Hussein Obama's staff who instructed Barack Hussein Obama on how to answer them. Even Steve Kroft guided Barack Hussein Obama in his answers. A spontaneous, random selection of Steve Kroft's questions allows three examples to come to the fore:

1. KROFT: This was your decision whether to proceed or not and how to proceed. What was the most difficult part of that decision? [By the formulation of the question that it was his decision and it had a difficult part, Kroft is telling Barack Hussein Obama how to phrase the answer. *A better question would have been: Would you please comment on the difficulty of such a decision in all of its aspects?*]
2. KROFT: It's been reported that there was some resistance from advisors and planners who disagreed with the commando raid approach. Was it difficult for you to overcome that? [The guideline regarding the answer to this question is that Barack Hussein Obama overcame resistance from his advisors and planners and

he has to comment on whether or not it was difficult. A better, non-keyed follow-up would have been: *Would you please comment on that?*]

3. KROFT: And it would seem to me that it sounds like you made a decision that you could accept failure. You weren't -- you didn't want failure but after looking at all the...55/45 thing that you mentioned you must have at some point concluded that it was that the advantages outweighed the risks. [This is not a question but the cue phrase is "you could accept failure". With the next sentence Steve Kroft cues Barack Hussein Obama not to mention failure, but to sidestep the issue and respond with a positive reaction like "the advantages outweighed the risks." A better formulation would have been to say: *And it would seem to me that it sounds like you made a decision that you could accept failure. Can you and what are the ramifications?*]

During the controlled interview the putative president of the United States of America, Barack Hussein Obama, stated that the Pakistani government must investigate and uncover the network that helped to sustain Osama bin Laden in his hideaway compound in Abbottabad, Pakistan. Barack Hussein Obama was emphatic in demanding that the government in Islamabad find out if any government officials, from civilian employees to military service personnel had knowledge of Osama bin Laden's hideout. To quote the bogus potus,

1. A similar statement was made by the chairman of the Senate Foreign Relations Committee, Senator John Kerry (D-Mass.), who said on Sunday that it was extremely difficult to believe that some singular members of Pakistan's government did not have any knowledge of any kind concerning where Osama bin Laden was located.

Barack Hussein Obama's national security advisor, Tom Donilon, told NBC's talk show *Meet the Press* that it was absolutely necessary to explain how it was possible for Osama bin Laden to have lived only a short drive from Islamabad, the nation's capital, and near the Pakistani equivalent of West Point for a total of six years. He also stated that the government of Pakistan must provide the United States with access to Osama bin Laden's three widows who had been taken into custody by the Pakistani government authorities after the commando raid.

3. Finally, Husain Haqqani, Pakistan's ambassador to the United States, said that Pakistan did not have any prior knowledge of Osama bin Laden's whereabouts. At the same time, ABC News reported on Sunday evening that according to a senior Pakistani official there may be some *rogue or retired* members of Pakistan's various intelligence agencies who may have provided support to bin Laden.

These are surely valid questions. The irony and the truth is that they all revert back to and apply to the person of Barack Hussein Obama.
