

CALLING OUT MONITOR'S TRUMP-BASHING

Monitor is a German television news program that investigates and reports on actual political and social situations in Germany and internationally. On September 10, 2020, Monitor aired a 20 minute video on President Donald J. Trump. It was nothing more than Trump-bashing. Georg Restle is Monitor's moderator. The English translation of the video, which is at <https://www1.wdr.de/daserste/monitor/sendungen/trump-autokrat-100.html>, is as follows:

Georg Restle (Fascist flags are shown): "And yes, there were also such flags in Berlin. German Empire, the symbol of a right-wing extremist conspiracy myth, and the U.S. President Donald Trump united in one picture. And no, that is not a surprise. For a long time, right-wing populists worldwide have declared Donald Trump to be their great role model, here in Germany as well. Whether Reich citizens or other right-wing extremists, they too hope for his re-election on November 3. Perhaps also because Donald Trump is coming closer and closer to their ideal of an anti-democrat. Like no other U.S. president before him, he has ignored and battered democratic institutions in the U.S. and abused his power for a single purpose: for himself. Golineh Atai."

An office for unlimited personal power? To protect his interests? To punish his enemies?

Donald Trump, US-Präsident: "When someone is the President of the USA, his power is total. That's how it has to be - total power! I have the right to do many things - people don't even know that. I have the right to do what I want as President. But, I'm not even talking about it!"

Donald Trump. Probably the most controversial President of the USA. He has damaged the institutions of the United States more than anyone else, critics say. The *Constitution* and Democracy undermined.

George Packer, Schriftsteller und Journalist: "We have never had a president who wanted to be a dictator and tried to be. Who disregards the *Constitution*, who doesn't even pretend to pay attention to it. Trump is a unique threat in our history."

How did Donald Trump shake the checks and balances - the pillars of the separation of powers? The legislature - for the founding fathers, for a president to undermine their power would have been an act of tyranny. And yet Trump did it again and again. For example here, in the construction of the border wall with Mexico. One of his most important projects.

Donald Trump, US-Präsident: "Build the wall - build the wall!"

The Congress explicitly did not give him any funds for this. No money for the border wall. Trump agrees, signs the budget. Then the turnaround. Suddenly he declares a national emergency on the southern border. A trick to get tax money for his favorite project. Later he admits that there was no emergency at all.

Donald Trump, US-Präsident: "I didn't have to do this. But I wanted it to go faster. I wanted it to be built faster."

Stephanie Llanes, Constitutional lawyer *Protect Democracy*: "It is clear that President Trump has abused and damaged the competence of Congress - and thus all three branches of government. Especially here, by usurping the budgetary rights of Congress".

The judicial power. What happens if the President violates their independence? And turns it into a political justice system? Erica Newland was a top lawyer at the Justice Department for two years. She examined the President's decrees to see if they were constitutional – or made them constitutional, as she says. Under Trump, she says, the ministry changed.

Erica Newland, Former U.S. Department of Justice lawyer: "It was as if our job was to bend the law and the facts to give Trump the answer he wanted – to provide him with an alibi.

Under Attorney General William Barr, the law is shifted even more in favor of the President. Barr makes it possible for Trump to prosecute opponents and for violations of the law by friends of Trump to remain without consequences.

Erica Newland: "The President and William Barr have accelerated the transformation of the Department of Justice. They turned a department that was supposed to serve the American people into the President's personal law firm that only protects Trump's interests, not ours.

For example, Roger Stone — Trump's croney, political consultant, conspiracy theorist. A court finds him guilty of making illegal arrangements with Russia and lying to Congress about them in Trump's last presidential campaign. The prosecution demands up to nine years in prison.

Donald Trump, US-Präsident: "In this country, we want justice. And Roger Stone was not treated fairly."

Stone will be made a free man by amnesty. He refused to testify against Trump in court — and was rewarded. According to a Harvard investigation, 31 of 36 pardons granted by Trump are controversial and served his personal interests and contacts. More than 2,000 former Justice Department officials are demanding the minister's resignation after the pardon for Stone. But nothing happens, nobody here resigns. Only Erica Newland has left. She has resigned.

The executive: What happens if the President abuses his power? Portland, Oregon - a city on the west coast. For over a hundred days, people have been demonstrating here for Black Lives Matter — an insult to Trump.

Donald Trump, US-Präsident: "This is much worse than in Afghanistan. I will send the military and solve the problem quickly."

Solve the problem quickly, against the will of one U.S. state. In Portland, unmarked militarized special forces, border patrol, and homeland security forces appear. They throw tear gas at civilians. They beat a Navy veteran who peacefully asks why the military came. They incite violence, throw protesters into unmarked trucks. They push and kick mothers protesting for human dignity. Demetria Hester is one of these protesting mothers. In Portland, the activist was already known as a victim of right-wing extremist violence. Even before her, the police did not stop.

Demetria Hester, Black Lives Matters Activist: "They are in full gear. If you don't move fast enough, they push you, trap you, and beat you. The symptoms of tear gas are terrible. Most mothers have experienced hormonal swings, insomnia, panic, and post-traumatic stress disorder."

The use of these special units against demonstrators: a clear violation of the law, even conservatives say so.

Paul Rosenzweig, former U.S. Department of Homeland Security official: "This is an authoritarian response to a protest. It reminds you of Russia or China. Since the American Civil War 150 years ago, we have had a law that forbids the President to use the military for civil purposes. If a head of state uses the military to suppress dissent, then Democracy is really at risk."

The right to vote makes the people sovereign. But what if access to the ballot box becomes more difficult for certain citizens?

Milwaukee, Wisconsin — in the Midwest. A swing state, one of those states where every vote counts and which can decide the election. Donald Trump won Wisconsin in 2016 by a narrow margin. One reason for this was that far fewer blacks went to the polls. Especially here, in Milwaukee's poor Northwest. Getting blacks to vote here means addressing decades of neglect.

Kevia Guiden, BLOC (Black Leaders Organizing for Communities): "There are five (Covid-19) masks in here, reusable ones. My name is Kiva. I need you to vote. Third of November— okay?"

Keviae Guiden works for an organization that does social work and political education. How to vote in the pandemic? In times of Corona? Kiva explains, registers their I.D.s, tells how to apply for postal votes. Because the postal vote is what counts. This is exactly what Donald Trump's campaign is aimed at.

Donald Trump, US-Präsident: "The postal vote, a disaster. These will be the most rigged elections in history. We do not want a postal vote in any state! It will lead to total electoral fraud!"

Trump's goal: To lower the voter turnout. If more citizens go to vote, disproportionately more blacks who traditionally vote Democrats will vote. This is precisely what he wants to prevent. For Angela Lang this tactic is electoral suppression.

Angela Lang, BLOC: "Election suppression is a huge thing in our community. Republicans in Wisconsin and across the country are using the global pandemic as a weapon to suppress voters. They're trying to slow down the pace of the mail so that people don't get their ballots in time."

Voter suppression by all means. Trump and the Republicans set off a huge wave of lawsuits in this election year. In nineteen states, the party is going to court to prevent more postal voting and to make access to the ballot box difficult in the first place. The trials are directed against initiatives like Keviae's. BLOC wants to fight in court to ensure that all citizens in Wisconsin can vote safely during Corona. The Republicans are taking action against this with their trials.

Angela Lang, BLOC: "All the time and money would be better spent to guide us well in these dark times, instead of making it more difficult for people to choose."

Donald Trump or the state is me. A president that the *Constitution* hadn't intended.

George Packer, Autor and Journalist: "He is what the founding fathers feared because they had experienced the King of England, who ruled absolutely. That's why they put all these controls in the *Constitution* so that there would never be a king in our republic. But all these controls are only as strong as the people who want to use and enforce them."

Perhaps that is what this is all about: whether on November 3, a man will be elected to the White House, who will further and permanently damage the *Constitution* of the United States of America.

Georg Restle: "That's what it's all about, and that would certainly not only have an impact on the USA.
