CONFRONTING THE DECEPTION

INVITATION

Dear Reader! *Would you like to read an excellent book? Would you like to read a very good book?* A much better question is: *Would you like to read a superb book?*

My answer is: Read Tabitha Korol's book, *CONFRONTING THE DECEPTION INFLAMED BY 9/11, FIRED UP BY EIGHT BAD YEARS*.¹ The book deals with Islam and Jihad, Islam and Jihad in American academia, and Islam and Jihad in American media. This review in essay form will present the American social issues vis-à-vis the ideology of Islam.

IN MEDIAS RES

Islam, which means *submission* in English, is not a system of divine laws, religious doctrine, and pristine theology. Islam is a vile sacrilege, an execrable political ideology that is camouflaged and assumed by naïve, frightened people to be the word of God. Islam is not a religion; it is anathema to God! Islam is political supremacism and totalitarianism.

The Koran forbids the questioning of what Islam teaches and propagandizes. In *CONFRONTING THE DECEPTION*, Tabitha Korol questions the Islamic pseudo-religion that has encouraged ignorance in American politics. Islam became a mind-set in politics that it is a religion of peace and tolerance. Instead, it is a pseudo-religion of war and intolerance of all people who are not Muslim. The evidence is in Islam's core teachings

that advocate the killing of non-believers, particularly the guideline verses for Muslims in the Koran, Sura 9, that have directed genocides against humanity since Islam's inception:²

9:1 [This is] A declaration of immunity from Allah and His Messenger to the polytheists with whom you had made a treaty.

9:5 When the Sacred Months have passed, kill the polytheists wherever you find them. And capture them, and besiege them, and lie in wait for them at every ambush. But if they repent, and perform the prayers, and pay the alms, then let them go their way. Allah is Most Forgiving, Most Merciful.

9:28 O you who believe! The polytheists are polluted, so let them not approach the Sacred Mosque after this year of theirs. And if you fear poverty, Allah will enrich you from His grace, if He wills. Allah is Aware and Wise.

9:29 Fight those who do not believe in Allah, nor in the Last Day, nor forbid what Allah and His Messenger have forbidden, nor abide by the religion of truth—from among those who received the Scripture—until they pay the due tax, willingly or unwillingly.

9:33 It is He who sent His Messenger with the guidance and the religion of truth, in order to make it prevail over all religions, even though the idolaters dislike it.

9:73 O Prophet! Strive against the disbelievers and the hypocrites, and be stern with them. Their abode is Hell—what a miserable destination!

9:111 Allah has purchased from the believers their lives and their properties in exchange for Paradise. They fight in Allah's way, and they kill and get killed. It is a promise binding on Him in the Torah, and the Gospel, and the Quran. And who is more true to his promise than Allah? So rejoice in making such an exchange—that is the supreme triumph.

9:123 O you who believe! Fight those of the disbelievers who attack you, and let them find severity in you, and know that Allah is with the righteous.³

Such intolerance and killings make Islam not only a false religion but also an ideology that recommends a death sentence for non-believers. The Koran, Muhammad, Allah, and Islam condone murder, beheading, sex slavery, human trafficking, wife-beating, honor killings, rape, pedophilia, to name only a few.⁴

The threats Americans encounter as individuals and as a nation are genuine. Muhammad established a dangerous political system hidden under the guise of religion that affects every American life. *CONFRONTING THE DECEPTION* gives a vivid history of occurrences and the efforts made by the terrorists of Islam who are known to be genuine and deceptive enemies to every person living in Israel and the United States of America.

The main aim of the deliberate pseudo-religion issues and progress is to promote propaganda in Islam's efforts to destroy American cultural heritage and peace. Every person who has lost his or her life or the life of a loved one in an attempt to better American existence deserves honorable appreciation. People need to know that Americans make sacrifices to safeguard the nation.

CONFRONTING THE DECEPTION is well structured and stimulates everyone to understand the threats that developed when Barack Hussein Obama became the 44th President of the United States of America – threats to America that continue to this day because he divided and debased the United States of America. His health reform legislation, commonly called Obamacare, was nothing other than a secret security force against

that Christians were polytheists because they believed in God the Father, God the Son, and God the Holy Ghost. Muhammad was intellectually unable to understand the concept of the Trinity. Muhammad hated the Jews because they refused to accept him as a prophet. Muhammad made unwarranted appropriation of Biblical history and personages, condemned the Jewish faith, and proclaimed himself as the last prophet. Muhammad did not perform any miracles. Muhammad could not show any requirement that he had to distinguish himself from a false claimant of prophesy. The Jews proclaimed him a madman or possessed by an evil spirit. This characterization of Muhammad was carried into the Middle Ages as describing Muhammad as being psychologically unstable, perverted, deplorable, and a false prophet, as well as AntiChrist. Muhammad owned sex slaves, was a polygamist, and lusted for carnal pleasure in the present and the afterlife. He is characterized as a merciless sadist, and destroyer of civilizations. These are all characteristics that the 48 male prophets and the seven female prophets of the Torah and the Bible do not possess.

Americans. Concisely stated, Korol presents the deception executed to the citizens of the United States of America and the idea that the Palestinian Muslims are being discriminated against by the “terrible Zionists.” Regardless of the definition one gives Islam and of what the general reading audience thinks about Islam’s being peaceful and tolerant, Korol clarifies Islam as an ideology that will always be a threat to freedom-loving Americans.

Superficially, a Muslim who may not openly follow the established Islamic laws – the Sharia – knows very well what the Koran and the Islamic verbal diarrhea teach in every Islamic school. The source of the problem is the argument that the Koran is the holy book of Allah that was handed down to Mohammed and the world via the angel Gabriel. (What an insult to the angel Gabriel!) The Koran must never change because Muslims believe it to be the word of Allah, containing holy, divine truths that are beautiful because they are perfectly rigid and used into eternity.

How can we describe the Koran? Ms. Korol’s answer is simple: most surely in terms of hate. Muslims have a violent behavior full of hate that is deviant from the norms of ethics and morals because Islam is unethical, immoral, and destructive. Muslims hate Kafirs (non-believers in Islam) so much that Muslims enjoy putting Kafirs to death and believe that by undertaking such killings, they will enter Jannah, the Islamic paradise. However, such killings are the manifestations of classical, physical evilness. We must not overlook this evil! We must fight it and exterminate it!

The ideology contains the reasons to eliminate cultures and implement Islamic laws. It elaborates a demonic doctrine of Jihad and institutes the comprehensive control of people in a belief system that Muslims call a divine theocracy, a *Gottesstaat*. Ms. Korol’s work proves that Islam is a political movement – one that uses the Koran to conquer the lands of Kafirs, the non-believers.

The Koran illegalizes assimilation. Non-Muslims must be converted from Christianity, Judaism, or other religions into Islam, or become second- or third-class subordinates and be specially taxed. Tabitha Korol vividly proves that Islam is a totalitarian belief system created to extinguish and supplant enemy cultures and, in particular, to annihilate Western Civilization. This goal is in Islam’s holy book that influences the Muslims to be triumphant in the whole world and rule over other religions to the degree

that other faiths will eventually become extinct. It is a forceful command of Muhammad/Allah that is sacred to Muslims. Islamic schools – the madrassas – argue that this action is the only hope that prevails is Islam.

There is a large section in American academia that kowtows to Islam. Higher education institutions have become infiltrated by Muslims and influenced by the propaganda emanating from Islamic student associations that spread the lie that Islam is peace and tolerance. These organizations are always eager to confront any force that tends to suppress their ideology. Muslim beliefs and tenets influence students to spread hatred against America and Israel.

The mass media also plays an essential part in supporting Muslim ideology. For instance, the mass media portrays Islamic groups, such as the Council on American-Islamic Relations (CAIR), as culture-friendly organizations, whereas in reality, they are the cell derivatives of Islamic terrorism. The goal of CAIR and other Islamic organizations is not the defense of civil rights, but the Islamization of the United States of America. The outcome is that the mass media sources will tend to hide any situation where Islam is criticized as being hateful Islamophobia, bigotry, and racism. The mass media will suppress any vital debate that is critical of Muslims and their organizations.

Since the destruction of the twin towers of the World Trade Center in New York City on September 11, 2001 (hereafter 9/11), the United States of America, Israel, and other nation-states that recognize freedom as an inalienable right have joined the survival battle that has been ignited by the vile and evil Islamic ideology. Part of that ideology was the attempt to turn a destroyed section of New York City, about two city blocks from Ground Zero (the destroyed World Trade Center), into an Islamic cultural center with a mosque. Being supported by all Islamic countries, the cultural center would have served as a foundation for the establishment of an Islamic caliphate in the United States of America. A shadow government would have come into being.

According to Tabitha Korol, the mass media in the United States, as well as in other countries, mainly in Europe, have been hiding the truth that Islam is subtly invading other nations and thus poses a substantial threat to the domestic and international security of those nations. The mass media conceal the dynamic changes in places invaded by Islam and the cultures supplanted by Islam. Ms. Korol rightly claims that

target communities in America necessitate an urgent evaluation due to the rigid, totalitarian, and dictatorial demands required by the Islamic cult.⁵ The allegiance of American Muslims is not devoted to the United States of America, but to their precise, local, Islamic group that is part of the worldwide Islamic community called the Umma.

The truth behind the Islamic deception documented by Tabitha Korol is that Jihad and deception are Muhammad-ordained concepts that make up the *modus operandi* of Islam. She believes that people around the world are brainwashed to disregard and hate Americans, disrespect their freedom, and underrate the signs of progress the United States of America has made since it was founded by its *Declaration of Independence* from Great Britain on July 4, 1776.

In the eight years of the recent problem – the presidency of Barack Hussein Obama, 2009-2017 – incidences such as female genital mutilation, honor killings, rape cases, street violence, intolerance, and divisiveness have increased due to the violent activities of Islam. In a combination of the false narratives and ideology regarding the pseudo-religion, the thinking of people inclined to Islam is gullible.

It is evident in *CONFRONTING THE DECEPTION* that Islam is a dangerous cult that threatens people globally. Islam plays a significant role in world history from India and Pakistan to Andalusia in Spain. Islam has experienced victory over victory. Since it began to expand violently under Muhammad starting in the year 622, Islam has conquered and destroyed into extinction many of the early civilizations. Among them were the cultures in Arabia, Mesopotamia (modern Iraq), Persia (modern Iran), the Levant, (modern Syria, Lebanon, Jordan, Israel), Egypt, the Maghreb (modern Libya, Tunisia, Mauritania, Algeria, Morocco, Western Sahara), Spain (Andalusia), Transoxiana (Central Asia: modern Uzbekistan, Tajikistan, South Kyrgyzstan, Southwest Kazakhstan), Hindustan (Modern Pakistan, India, Bangladesh), and Anatolia (modern Turkey). Accompanying these conquests were innumerable crimes against humanity. All evil has a beginning, and the origin of Islamic evil is Muhammad.

The Islamic Hijra (migration), which is non-violent Jihad, also called civilizational Jihad or Islamization, is entirely underway in Europe and North America, actively supported

by Muslim countries and the United Nations.⁶ In any country where Muslims live or in any country to where Muslims migrate, there is no peacefulness and tolerance from them.

Islam's mode of propaganda attempts to make the person-cult surrounding Muhammad appear holy in the eyes of innocent people. In truth, Islam has *no raison d'être* to spread its faith other than to seek world domination.

Tabitha Korol states that one of the primary characteristics of Islam is the Jihad war, which has always been the goal of Islam since its commencement in its quest for world domination and the suppression of non-Islamic peoples. Islam has always erased a culture's past in such a manner that the culture eventually eviscerated from humanity forever. Islam's goal is to delete the past history of the United States of America, as well as the country of Israel, so that both will be deprived of existing in the future.

As in contemporary America, Islam has been invading many parts of the world like uncontrollable cancer. Many democratic nations are unable to control Islam because Islam has expanded under the guise of being a multi-cultural, religious advancement in the targeted nation and is now beyond control. As outlined by Tabitha Korol, the incidences regarding Islamic deception are due to the reality that many democratic countries internationally have been invaded with Jihadi criminals who are an integral component of Islamic expansion. Such Islamic elements are further advanced by communist academicians, pseudo-secular political leaders, liberal mass media, phony intellectuals, and leftist liberals, in this present author's opinion: *insanus capitibus* (crazy heads). The groups of leftist liberals create an environment where the Jihadists become strong and assist this evil cult in accomplishing its goals.

Using the tactic of deception, these Islamic sympathizers have set up an unholy nexus with Islamic fascists. As one of the fortunate people who evaded the mass assassinations of the bombing of the World Trade Center on February 26, 1993, and the destruction of the World Trade Center on September 11, 2001, Tabitha Korol offers

tremendous scope and a way of comprehending the threats of the pseudo-religion of pseudo-peace and pseudo-tolerance.

Tabitha Korol speaks about the Jihad holy war that has threatened the lives of many Americans. The Jihad war intends to establish Allah's territory not only throughout the world but specifically in this day, on the North American continent, and further expropriate the land and booty. According to this sect, death to Americans will bring eternal paradise and divine advantages, but to Muslims only.

With complete domination, Islam intends to erase the political organizations with the purpose of conquering the exenterated organs of freedom. Tabitha Korol presents the factual thesis that Islam does not acknowledge the theories of justice and morality. The ideology of conquest supports Jihadi terrorists and eliminates the captives of terrorism. This cult keeps changing its nature by taking on new appearances but always disguised as freedom, tolerance, multiculturalism, and even progressivism.

CONFRONTING THE DECEPTION is a masterful work in elaborating on what is changing in America. Tabitha Korol displays the numerous threats that people meet once they encounter copious connections with Koranic verses. Trusted documents and historic accounts expose the mentality that leads a Muslim to become a Jihad terrorist. *CONFRONTING THE DECEPTION* discusses false information about Islam with evidence upheld by indisputable proofs. All of this information helps the book's audience to comprehend the distortion of facts. The reader is compelled to believe that the essays' contents are correct.

Muslims are interested in concealing their opinions and views. Most of them declare that their religion is peaceful and tolerant by propagandizing information. This claim is oxymoronic when compared to reality. Peace and tolerance are on their lips, while war and destruction are in their beings! They intend to bulldoze the current political and social structures into oblivion. Islam achieves dominion through terror, intimidation, and violence.

Since this person-sect started, Islamic ideology has been passed on to succeeding generations with successful conquests. Everywhere Islam exists, it uses force to intimidate the non-believers. For instance, up to one billion people have lost their lives combatting Islam. The option they give to the non-believers is to convert into being a

Muslim by force or become physically eliminated, or be an unequal, *jizya* tax-paying subject called a *dhimmi*, which is also a form of elimination ... extermination by exploitation.

CONFRONTING THE DECEPTION is a warning of the threat posed to American culture. Ms. Korol writes that the eight years Barack Hussein Obama was in power created hopes among Obama supporters that America would overcome Islam and repair the damage Islam had caused. However, under Barack Hussein Obama's non-leadership America became *dhimmi*-like with financial support to Muslim regimes, particularly Iran, and their strategy of conquering the world with Islamic terrorism. Barack Hussein Obama encouraged the grip-jaws of Islam and urged Islam to crush American culture.

With the election of Donald J. Trump as the 45th President of the United States of America and the executive order that compelled the deportation of certain Muslims, it was argued that the Trump administration had initiated religious discrimination. However, this is not the case. If the reader googles politics, religion, and Islam, websites referring to political Islam will appear, and the information at these websites will show evidence that Islam is not a religion, but a political, ideological movement.

Islamic ideology has spread not only in the United States of America but also in other parts of the world. In the modern nations currently dominated by Muslims, the political system is based on this pseudo-religion. For instance, the governments of countries such as Afghanistan, Pakistan, and Saudi Arabia use Sharia law to control their populations.

CONFRONTING THE DECEPTION argues that Islam is slowly operating in the contemporary world through indoctrination and intimidation. *CONFRONTING THE DECEPTION* also provides cogent instances and a thorough description of how Jihadism has become a global problem.

This aspect of the ideology is spread through their religious institutions, and they have the goal of destroying the civic institutions of America. The Islamic deception –

Muhammad said that war is deceit⁷ – has been dividing people into distinct antagonist groups, distorting people's language, compromising laws and policies, and redefining the family structure according to the precepts of Islam. Many Christian theorists insist that the *Constitution for the United States of America* should protect freedom of religion.⁸ This argument is genuine and should be attended to by the lawmakers. In the case of Islam, however, there is a need to identify the truth that Islam is not a religion, but a political organization.

In the United States of America, there is a group of legislators whose opinions suit the argument of *CONFRONTING THE DECEPTION*. Former deputy attorney of the United States for the Southern District of New York and presently a columnist for National Review, Andrew C. McCarthy III, states that when describing Islam, we should center the discussion not solely on Islam as being a religion, but on its being a political movement. His argument is inclined to the aspect that Islam is a political movement that uses divinity to propagandize and spread its ideology to the people globally. There is more than enough proof that Islam hides under its religiously-related aspects in order to disguise the dangerous ideology and its impact on Muslims and non-Muslims.

It is essential to understand that Islam is slowly eliminating the common-sense freedoms and providing an impetus to the demolishing of American historical monuments. The negative consequences of multiculturalism caused by the Muslim pseudo-religion bullies good-hearted people and slyly encourages people to suspend intellectual discernment. Ms. Korol states that islamophobia distorts the American citizens' inalienable rights and forces the citizen to become submissive to the ideology that has been created by the cult Islam.

The most undemocratic form of equality is the instance where Islam forces people to become members of the Umma. When this cult spreads throughout the United States of America, Americans are in danger of losing the great religious freedom they have

lived throughout the past 240-plus years that is guaranteed by the *Constitution for the United States of America*.

The spreading of Islamic conquest ideology is increasing in the American population, and this has sparked a profound disconnecting of people's faith. The expansion of Islam in America has threatened the nation-state's security. Islam's conquest-progress offers the Muslim activists the incentive to protect the Islamic policies that are not in accordance with the laws and regulations of the United States of America.

Islamic terrorists have killed more than 35,500 innocent individuals since 9/11. It was not only Osama bin Laden who killed many Americans on September 11, 2001. It was a group of devout Islamists guided by the propaganda of Osama bin Laden who had a negative opinion towards the United States of America. The number of terror attacks has been increasing as a result of the spread of Islam, which is infiltrating almost every non-Islamic country in the world, particularly in North America, Europe, and Africa.

Before and after the presidency of Barack Hussein Obama, who decimated American military power, the United States has formed a strong military and devised strategies to develop counter-actions to combat Islamic terrorists who feel themselves immune from persecution because Muhammad and Allah promise them a win-win-situation: be successful in one's Jihad on earth and enjoy the reaping of earthly rewards, or if one becomes a Jihad martyr for Islam, one will reap the rewards of Jannah and go directly to paradise where the martyr will eternally enjoy the rewards of the 72 virgins, who are really 72 white grapes, due to a mistranslation of the Aramaic term *houris*.

Muslims promise non-Muslims that their religion is peaceful and tolerant. That is the deception of deceptions. Islam is peaceful and tolerant for Muslims only, not for Kafirs. Being tolerant of Islam, which itself is the epitomé of intolerance, will lead to the destruction of civilization.

Americans are confused about Sharia, Islamic political ideology, and so-called Islamic religious beliefs that change the way of thinking regarding Islam. Many people are Christians, and there are no traces of Sharia in Christianity. Even if one is Hindu, Buddhist, or Jew, there are no traces of Sharia in these recognized non-pseudo religions.

Hindu, Buddhist, Roman Catholic, Protestant, and Jewish religions have a process of redemption that is ethical (concerning the conduct of one's life) and moral (pertaining to the rights and wrongs in life).

In Hinduism, salvation comes through a process of self-realization, a process known as *Moksha*. In Hinduism, redemption is through *Moksha*, not through Jesus Christ, which is not to say it is JHWH's paradise, but it is to say that for a Hindu, as well as a non-Hindu, a comparison to JHWH's paradise is possible.

In Buddhism, one reaches salvation by being free from suffering and reaching *Nirvana*. In Buddhism, redemption is through reaching *Nirvana*, not through Jesus Christ, which is not to say it is JHWH's paradise, but it is to say that for a Buddhist, as well as a non-Buddhist, a comparison to JHWH's paradise is possible.

Roman Catholicism, Protestantism, and its various branch denominations such as Methodism, Evangelicalism, Lutheranism, etc. reach salvation through JHWH and Jesus Christ. For believing Roman Catholics and Protestants, redemption is through Jesus Christ. JHWH's process of redemption is by delivering salvation through the crucifixion of Jesus Christ, the highest good of having JHWH's Son die on the cross for the salvation of human sinners. This process is the way to JHWH's Paradise.

In Judaism, there is no trinity. There is one God only! Jews do repentance for their sins by conducting ethical self-transformation. Jews believe that when the Messiah comes, the ills of humankind will be solved, if not vanish. The Messiah will cause the spiritual regeneration of humanity and redeem the world from war and suffering, thus leading humankind to universal brotherhood under one God. Jews prepare for the day when the Messiah (*Moshiach*) will come by striving to live their lives by honoring the words of the Torah and conducting themselves according to the laws of the Ten Commandments.

Two primary Jewish texts describe the process of repentance. The first text is by the Sephardic Jewish philosopher Maimonides (1135-1204), who wrote about the process of repentance in *Rules of Repentance* in the *Mishneh Torah* (ca. 1170-1180). The second text is by Rabbenu Yonah of Gerona 1200-1263/1264), who wrote the *Gates*

of Repentance (first appeared in 1505), a standard work of Jewish ethics which says that a sinner can repent by:⁹

- acknowledging the sin;
- acting and speaking with humility;
- acting in a way opposite to that of the sin (for example, for the sin of lying, one should speak the truth);
- confessing the sin;
- correcting the sin however possible (for example, if one stole an object, the stolen item must be returned; or, if one slanders another, the slanderer must ask the injured party for forgiveness);
- forsaking the sin;
- praying for atonement;
- pursuing works of lovingkindness (*chesed*) and truth;
- refraining from committing the same sin if the opportunity presents itself again;
- refraining from lesser sins for the purpose of safeguarding oneself against committing greater sins;
- regretting the sin;
- remembering the sin for the rest of one's life;
- teaching others not to sin.
- understanding the magnitude of the sin;
- worrying about the future consequences of the sin;

Judaism places a high value on morality that is defined in the laws of God: the Torah and the Ten Commandments.

Salvation is closely connected to the idea of redeeming the people of Israel from myriad exiles. When the Messiah comes, there will be a final redemption from the Jews' contemporary exile, which is only a small portion of the Promised Land. "All Jews will return to the Land of Israel, where they will throw off the yoke of their enemies and

undergo a complete spiritual revival. They will embrace the faith of their forefathers and dedicate themselves to God's service forever."¹⁰

In Judaism, God is the universal spirit and Creator of the World. God is the source of all salvation for humanity. However, humanity must honor God by observing God's principles embodied in the Torah, in which God taught His people the sanctification of the individual, and He expects them to function spiritually according to the rules of the Ten Commandments.

In Judaism, salvation is not limited to Jews only. Still, people must observe and practice the ethical patterns of behavior that are codified in the Torah and the Ten Commandments, which are precepts to live the ethical and moral way of life.

Although there are claims that Islam is the salvation for the world, Islam has no ethical and moral process to deliver salvation to human sinners.

There are 86 references to Jews in the Koran. None of the references are positive. The goal of Islam is the destruction of cultures and peoples who do not believe in Allah/Islam/Muhammad. The goal of JHWH is the creation of eternal life through the redemption of the JHWH code by Yahshua.

To compare the crucifixion of Jesus Christ to being killed for Allah and to kill in the path of Allah is the highest form of blasphemy of JHWH. The lack of understanding of what is entailed in the Islamic pseudo-religion exposes people to the lies of Islam that are reshaping the non-Islamic countries. Even if one

converses with a well-meaning or well-intentioned person to understand the meaning of Sharia, that person will not be able to comprehend Sharia because there is no connection between Islam and Christianity, Judaism, Hinduism, or Buddhism.

The United States is roiling with uncertainties and chaos that has been well stated in Tabitha Korol's book. She talks of the Leftists, who once had the aim of impeaching a fairly elected president and compelling others to bow before Marxism. The explanation of this history is what Tabitha Korol is reminding us of in her book on what is pending in the future if the spread of Islam is not brought to an end. Some persons in the American mass media such as Glenn Beck have argued that Islam poses internal and external threats not only to the Americans but also to the entire world. The reason as to why Israel stands with the United States of America is that Israel shares the same beliefs in freedom. This fundamental belief proves that the two countries are different from what Islam believes. Islamic belief is an ideology that prospers in killing, bloodshed, and subjugation. The conflict with Islam is a struggle of human development to death.

Islam will always remain consistent with its teachings of claiming peacefulness and tolerance when they are in the public limelight. Islam is a fascist political system that has further advanced terrorism and hatred. Islam is not interested in the pursuit of lofty objectives of democracy, human rights, peace, and tolerance. Absolute conformity, oppression, indoctrination, a fanatic belief system, and Islamic rigidity are exactly outlined by Ms. Korol. She insists that Islam places its ideology above human nature and humanity and carries out the policy of eliminating anybody who seems to be detrimental to its inelastic, inhuman system.

CONFRONTING THE DECEPTION knows that Islam is a political ideology of destruction under the guise of theology. Die-hard Muslims scream hatred towards non-Muslims. Islam's goal is: **Death to America and Israel!** (and conquest of the world!) It has become much more than just a slogan. Daily, Islam is working hard to implement this objective. Mohammad established the foundation of an Islamic empire aimed at killing Pagans, Christians, Jews, and all non-Muslims. Present Muslims inherited Muhammad's Allah-sanctioned methods of expansion by conquest, beheadings, and genocide.

During the era of colonization, political powers used wars to acquire political control over the colonies. However, history shows that there was no precise political ideology to kill a person based on his or her religion. In Islam, one of the principles is the division of humanity into two categories: the believers and the infidels. The idea of converting infidels into Muslims by force makes this pseudo-religion a dangerous cult and violates the right of individuals to worship morally, ethically, and freely.

The influence of converting people to Islam is prevalent in madrassa schools that involve high degrees of indoctrination. In Islam, the brainwashing process begins in

mosques and in madrassa schools where there are rewards to the best learners. The teaching that people receive in Islamic institutions will never comply with logic and human nature. Muslim indoctrination involves Mullah-sanctioned answers, and failure to accept such teachings results in brutal punishment.

Some scholars have honored Tabitha Korol for her stand against Islam. Dr. Bill Warner, the founder of the Center for the Study of Political Islam, describes the substantial threat posed by pseudo-religion Islam: there is an ordered Islamic doctrine that powers every Islamic gain in the fields of culture, education, the media, and politics.

For almost four years, America has been caught in a problematic peacetime period. The movement to impeach President Donald J. Trump led to a constitutional showdown similar to the triggering of the American Civil War during the presidency of Abraham Lincoln. In such moments, it is not a surprise that the significant and old security threats have been placed in the background. Some problems have come to haunt Americans. The current of unappeasable disparities and mutual hostilities have led to an attempted silent coup that could have likely triggered another civil war.

The attack of 11 September 2001, a terror incidence that Tabitha Korol has used as proof of why she is fighting Islam, is an incidence that will ever remain in the memory of Americans. The 9/11 attack exposed the country to a possible occurrence of a future civil war caused by religious disparities. Ever since 9/11, there has been the establishment of hostile movements, most of them mothered and fathered by the Democrat Party, the Left, and Antifa organizations. There are Jihadists ready to undertake their holy war, and there are other groups prepared to counter them in a crusade to stop Islam from expanding and conquering.

Tabitha Korol in *CONFRONTING THE DECEPTION* goes beyond the terror attacks that happened in America nearly two decades ago. Initially, before this incident, people were warned that peace was already not with them as opposed to the notion many people had that the threat was new in the eyes of America.

It was known a long time before 9/11 that Islam does not hold comprehensive human rights in high regard. The idea of what is good and what is wrong, the rule of law, judicial proceedings, criminal justice, administration, civil and family laws have been

Tabitha Korol warns that the presence of Jihad in America has dire consequences far above what people can realize. Her conclusion that the peaceful and tolerant concept that Islam is insinuating is a *grande déception*. This essayist knows that only a minority of the American population are Muslims. However, this small portion with Islamic ideology is very much interested in bringing America to its knees. Ms. Korol declares that Muslims constitute a substantial threat to American culture and heritage. Humanity has long assumed Islam to be the peril. She describes in detail how Islam's fictional political caliphate and their belief in Muhammad/Allah compromise the security of Jewish and Christian civilizations.

Korol relate what the violent followers of Mohammed completed in their early conquest of Mesopotamia, Babylonia, Persia, Afghanistan, North-western India, Egypt, and North Africa. The Islamic theory of violence has always existed and has always been used in this world.

CONFRONTING THE DECEPTION states that the United States, Israel, and other countries across the globe value their freedoms and must be willing to fight for such liberties everywhere. Other research shows that peace-loving and traditional people should have used a sword to defend their heritage, ethics, and morality. Apart from forcing conquered peoples into their ideology, Islam made those people slaves or killed them outright.

Islamic fanatics – are there other kinds? – represent the fantasy of their pseudo-religious paradise. The conquests and propaganda transformed people and disengaged their lifelines with antiquity, which Islam destroyed. Islam, through dishonesty, mass murder, assassination, and incitement, has stolen people's wealth and plundered ancient territories and cultures. This cult has accomplished many of its purposes with absolute genocide and cruelty. As illustrated by Tabitha Korol, many free thinkers, artists, intellectuals, poets, and philosophers have been eliminated in the name of achieving Islam's goal of conquering the world.

CONFRONTING THE DECEPTION debates the purpose of the criminal movement that hides the reality of Islam. More precisely, the group emphasizes political Islam. Tabitha is a feminine first name from the Aramaic language that translates into *gazelle* or *deer* with a broader sense of *having the eyes of a gazelle*. In the Arabic language, this sense can be interpreted as *having beautiful eyes* or *beauty*.

The origin of the name is found in the New Testament. Tabitha or Tabita (Tabea in the Luther translation of the Bible) was a disciple of Jesus from Joppe (Jaffa, nowadays a district of Tel-Aviv, Israel). Tabitha was well known for her warm-heartedness and helpfulness. Tabitha made garments for the poor. She fell seriously ill, died, and was resurrected by Peter. October 25 is Saint Tabitha's Day of Remembrance.

No book review of *CONFRONTING THE DECISION* can do justice to Tabitha Korol's book. It is a well-structured, documented research consisting of 90 essays averaging three pages each with 822 endnotes that outline several Islamic consequences. The book's structure enables the reader to understand how one essay is a perspective that interacts with a successive essay's perspective. Tabitha Korol's book is a *must-read* because it presents valuable insights into the hidden, indeed, deceptive aspects involving American academia and American mass-information/media collusion with Islam.
