The essence of Jesus' words enters everyone's heart because this day touches the minds and hearts of many people during the Christmas celebration. This time of year gives society reflection on the Birth of Jesus but also reminds us about the joys in life, especially the innocence of our children.

Children are the greatest gift in life and American families realize this all the more when their hearts are filled with the anticipation of Santa Claus coming to fulfill their Christmas wishes. In many European and in all German-speaking countries it is the *Christkind* (Christ Child) who brings the gifts and joy on Christmas Eve. In Europe Santa

Claus fills the children's shoes, boots, or stockings when children are sleeping on the eve of Nicholas Day, 6 December. The Christmas Day celebration brings memories and traditions to families that will be passed on in following decades.

The naysayers want to destroy the spirit of Christmas because they feel too much money and advertising is spent on material things vis-à-vis the celebrating of the Birth of Christ. However, it is not true. Christmas has positive stimuli for businesses, churches, families, communities, and individuals because they practice giving, family unity, and love. The spirit of Christmas lives on and becomes more popular each year, thus helping the economy. The employers are more generous at the end of the year during Christmas holidays. The society as a whole is trying to feed the hungry and disadvantaged by providing free food, financial donations, and gifts for children all over the world. The Salvation Army helps families that are in need.⁴ The United Way assists the community during Christmas with financial help, rental assistance, utility bills, food, toys, and moral support for those living in poverty.⁵ Yet, many secular organizations are trying to destroy the American Christmas spirit.

Commercialization Confronts Christmas

There are those who condemn Christmas as a money-making business scheme to get Americans to spend money in the stores. They believe the entire reason for celebrating has been lost in Macy's sales and Wal-Mart seasonal offerings, the gluttonous behavior to self-indulge with food, new toys, or new houses, or new cars, or new whatnots. The television commercials promote Christmas as if it were the Super Bowl for the sole purpose of attracting more people to spend more and more money, or if the people do not have money, to take out a loan. At every corner people are cashing in on Christmas from banks, school bakery sales, malls, department stores, and the dollar stores to name a few. The television networks receive billions of dollars in advertising that promote a new male fighter doll and a new Barbie doll that your youngster and your little girl must have to be happy for Christmas. Sport franchises make deals with the television networks to share profits during the Christmas holiday. A

sports stadium will be redecorated with sponsors so they can advertise to consumers with billboards during the sporting events. Christmas starts too early, thus causing the loss of the true intent of celebrating the Birth of Jesus Christ. The modus operandi means that advertising and marketing begin so early in order to allow businesses more time to make more profit at the end of the year.⁶

The naysayers believe Christmas is no longer a celebration of Jesus Christ's Birth. It is a commercialized racket that capitalizes on free enterprise to maximize revenues during this holiday season. The American Christmas has moved away from the tradition of hanging stockings on the fireplace mantle or near the chimney while waiting for Santa Claus. The carefully placed ginger bread man, the smell of evergreen trees, and hundreds of lights and candles ... all have become dependent on commercialization.⁷

The commercials do not mention that Christmas, or the use of *Xmas* is the day to remember the Birth of Christ. The use of the term *Xmas*, not the term itself, is insulting and demeaning. Businesses just want to advertise, the moneychangers ensure that Americans go into debt, and the media just want to celebrate a holiday without acknowledging Jesus Christ's Birth. The American economy with Christmas sales, Christmas discounts, the increase on credit card limits, and billions spent on marketing, depends on the influx of cash and credit that is spent throughout the Christmas holidays.

Atheists Assail Christmas

California claims to be a very progressive state with its constituents more tolerable to the actions of atheists. Sunny Santa Monica, California is the nascence of the atheist movement against Christmas. In tribute to the Birth of Jesus Christ, Santa Monica, California named itself *The City of the Christmas Story*. In Palisades Park there was a large painted sign of Jesus Christ in Bethlehem on display that atheists wanted removed because it was on the city government property. In 2011, the avowed atheist-in-chief Damon Vix of Burbank, California won two-thirds of the booths in the annual, city-sponsored lottery to rent out spaces in a live-sized Nativity Scene in Palisades Park. However, he put up one item only: a sign that read *Religions are all alike founded on fables and mythologies*. Mr. Vix left the rest of his allotted spaces empty. As a result of Mr. Vix's assailing Christmas, the city has permanently banned its sixty-year Nativity Scene *Christmas Story* tradition.

Vix and similar atheists contend that Christianity breeds hate and that Christmas is a symbol thereof. However, this is such a closet-minded standpoint that atheists forget, or like to forget, that under Christianity women have been held in high regard and have achieved equality with their male counterparts. Moreover, human sacrifice and slavery became outlawed in Christian cultures. In the same historical time period heathen Arabs

still made human sacrifices. Islamic states have outlawed slavery, but not concubinage or volunteer workers who receive no wages. Atheists propagate abortions and even euthanasia. Indeed, atheist cultures are no different from pagan cultures and cults in that each have always relied on oppression and even murder to propagate their beliefs. Atheism is not reasonable, but illogical and inhuman. Atheists are enthusiastically prothemselves.¹⁰

Some atheists have no problem with the celebration of Christmas. It is the meaning of the Christmas message and the belief in God the Father, God the Son, and God the Holy Spirit that riles them into taking ecstatic standpoints. Some atheists are very clever in their choosing to attack and fight the Christmas Season in California because there atheists have a historical past of instigating new laws that have an impact on the entire country. Atheists desire local, national, and global coverage of their viewpoints when spreading their attacks on Christmas celebrations in the United States of America.

Atheist advocates do not believe that the federal government, states, or cities have the right to make propaganda on public grounds celebrating Christmas. The legal argument by atheists surrounding their right to challenge the open display of any reference to Christ always rests with the possible government (state) support of church initiatives. Atheist followers believe they have legal standing that the separation of church and state must be honored. This argument concerning the glorification of Christmas on government property in Santa Monica, California left the decision to the California judicial system and its liberal-oriented justices. The legal charge against the government of Santa Monica was led by well-known atheist Damon Vix, whose goal is always to condemn the holiday celebration that has Christmas trees and public displays of Jesus. His actions were a direct attack on Christmas celebrations by using the freedom of expression guaranteed by the First Amendment to the *Constitution for the United States of America*.¹¹

Atheists have tried to discredit Christmas because they believe Christmas is a mythical celebration that goes against their atheist beliefs and traditions. They are constantly making the point that Christians have lost faith in the belief of Jesus Christ. The atheist advocates have successfully made organizations become overly sensitive to the American Christmas holiday. These attacks on Christmas are purposely done to erode the spirit and meaning of the Christmas holiday celebrations. In many places in the United States of America people celebrate the holiday with non-religious scenes. Public vocalizations of *Merry Christmas* are not permitted for fear of being brought before a court of law for the crime of offending the non-believers.

Atheism has crept into the minds of the society by using the First Amendment to force society to open up the proverbial Pandora's Box of troubles. Atheists attack Christmas as commercialization, mythical beliefs, Christian's loss of faith, and state and church working together in society. Atheists believe the Christmas holiday season is nothing more than a marketing scheme to trick the American people into going into debt for the Christmas holidays. The propaganda on television, radio, and in the media all have monetary reasons for wanting to push the spending on Christmas day. Atheists point out that very seldom do you hear or see anyone celebrating the Birth of Jesus, which if celebrated, the atheists would attack in every way possible. They point out that the celebration of Christmas is wrapped in symbolism like mythical characters and that even Great Britain not always observed Christmas and that Nativity Scenes are being banned – oops, phased out – in the schools. 12 Atheists cite the fact that the British people considers themselves Christians, but they do not believe in Christmas, while British employers have prohibited Christian ornamentations and references to Christ out of concern of offending non-Christians. 13 The atheists relate to Britain because there are attitudes that support the destruction of the Christmas holiday celebrations that could possibly propagandize the disdain for the holiday globally and consequently gather support for the destruction of Christmas.

The atheists are making an organized effort to destroy Christmas celebrations in the public arena. They are using the same commercialization, advertising, and free enterprise to discredit the Christmas holiday season that the free market economy produces. The perfect example is Damon Vix in Santa Monica, California who purchased his own public advertising in the middle of town and legally discredited Christmas. This is physiological warfare to create doubt in the minds of the Christian believers that Christmas is corrupt. The strategic move in California concerning the issue that church and state should be separate has reached millions via the sympathetic media.

In 2012, the targeted destruction of Christmas strategically concentrated itself in New York City, ¹⁴ where American atheists collected funds to purchase a large billboard in Times Square, one the most visited places with diverse people from every cultural heritage. The billboard had Santa Claus and Jesus on a cross with the captions *Keep the Merry* and *Dump the Myth*.

The California and New York attacks on Christmas were not by mistake and those in the future will not be simply coincidental. Atheists are seeking to discredit Christmas in the cities that have the most diverse populations. There is reason for concern because the secular, militant atheists are becoming more and more aggressive in attacking Christmas tradition. The atheists are being led by the organization American Atheists, which also funded the protests in Ohio concerning the word *salvation* on Licking Valley T-Shirts in Newark, Ohio; the saying of a prayer before the school's football games; ¹⁵ and the placing of crosses along highways in Utah by the private Utah Highway Association to memorialize slain police officers with white roadside crosses. American Atheists protested that the white crosses conveyed the implication that the state of Utah was endorsing Christianity. ¹⁶

The targeted attacks on Christmas by atheists gain momentum because they are using the United States laws to support their opinion that the state and church should be separate. They often quote Thomas Jefferson (1743-1826; President 1801-1809) and his concept of a *wall of eternal separation between church and state* that was the original rationale placed in the *Constitution for the United States of America* on this matter.¹⁷

On October 7, 1801, the Danbury Baptist Association of Danbury, Connecticut sent a letter to the newly-elected third President of the United States in which they asked him why he had decided not to proclaim a period of fasting and a national day of Thanksgiving as had his predecessors George Washington (1732-1799; President 1789-1797) and John Adams (1735-1826; President 1797-1801). Thomas Jefferson's answer was phrased in the context of the relationship between the federal government and the state governments. Long after the letter was written Thomas Jefferson's position on the role of religion in a civic, democratic republic was falsely interpreted and this wrong interpretation has stayed with American judicial decisions.

To messers Nehemiah Dodge, Ephraim Robbins, & Stephen S. Nelson, a committee of the Danbury Baptist association in the state of Connecticut.¹⁸

Gentlemen

The affectionate sentiments of esteem & approbation which you are so good as to express towards me, on behalf of the Danbury Baptist association, give me the highest satisfaction. my duties dictate a faithful & zealous pursuit of the interests of my constituents, and, in proportion as they are persuaded of my fidelity to those duties, the discharge of them becomes more & more pleasing.

Believing with you that religion is a matter which lies solely between man & his god, that he owes account to none other for his faith or his worship, that the legitimate powers of government reach actions only and not opinions, I contemplate with sovereign reverence that act of the whole American people which declared that their legislature should "make no law respecting an establishment of religion, or prohibiting the free exercise thereof;" thus building a wall of eternal separation between Church & State. Congress thus inhibited from acts respecting religion, and the Executive authorised only to execute their acts, I have refrained from prescribing even those occasional performances of devotion, practiced indeed by the Executive of another nation as the legal head of its church, but subject here, as religious exercises only to the voluntary regulations and discipline of each respective sect,

[Jefferson first wrote: "confining myself therefore to the duties of my station, which are merely temporal, be assured that your religious rights shall never be infringed by any act of mine and that." These lines he crossed out and then wrote: "concurring with"; having crossed out these two words, he wrote: "Adhering to this great act of national legislation in behalf of the rights of conscience"; next he crossed out these words and wrote: "Adhering to this expression of the supreme will of the nation in behalf of the rights of conscience I shall see with friendly dispositions the progress of those sentiments which tend to restore to man all his natural rights, convinced that he has no natural rights in opposition to his social duties."]

I reciprocate your kind prayers for the protection & blessing of the common father and creator of man, and tender you for yourselves & the Danbury Baptist [your religious] association assurances of my high respect & esteem.

Th Jefferson Jan. 1. 1802.

Although atheists always quote the statement and the metaphor by Thomas Jefferson, it is still one of the most misunderstood and misused statements/metaphors in American history. If one examines Thomas Jefferson's political life beginning with his being the second governor of Virginia from 1779-1781 and continuing with his public service to the United States of America, one will conclude that Thomas Jefferson was a friend of religion.

The First Amendment to the *Constitution for the United States of America* states that "Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof;" This is a check and restraint on the federal, civil government. It is not a check and restraint on religion. Jefferson feared that the federal government would corrupt a person's religion by interfering with it. The metaphor <u>a wall of eternal separation between Church & State</u> is nothing but a metaphor that has undergone legal application. When metaphors become laws, the meaning of the law is distorted concerning the subject in question. Laws should not be passed or judicially decided based on figures of speech. Thomas Jefferson was conveying the thought that the guarantee of freedom of religion was not written in the *Constitution for the United States of America* to protect the civil state from religion. The constitutional guarantee of freedom of religion was created to protect a free and independent religion from federal control. This was and still is in agreement with the view of all of the Founding Fathers that religion is indispensible for maintaining social order and political well being, without which a country cannot be free.¹⁹

Muslims Malign Christmas and Murder Christians

Muslim religious beliefs come from Muhammad and his dictating of what he said was Allah's commands as he hallucinated and invented them and placed them in the Koran.²⁰ Therefore, Muslims do not believe in Christmas celebrations as a Christian

observance. In the United States of America and in other democratic republics of the Western World one can convert to any religion based on one's own values. Muslims in the United States have the choice to celebrate Christmas, not because Christmas welcomes everyone to Christ's table, but because Christmas is a holiday.

In the United States of America Muslims have mosques in cities and rural regions of the land. However, it is our constitutional stance concerning freedom of belief that allows the Muslim cult to exist without any hindrance on American soil.²¹ Every time Muslims kill an American or Christian in the name of denouncing Christmas it somehow underscores the irony to the highest degree that the world's poor, hungry, and persecuted are allowed into free America.

The destruction of Christmas by Muslims is representative of Islam. The teachings of Jesus tell us not to judge people based on what they worship but judge them by their deeds. The teachings of Muhammad force people to worship only Muhammad and the moon god Allah. Islamic deeds are not peaceful and they are not tolerant. During the Christmas holidays, people give unconditionally to show they believe in the Birth of Jesus Christ. This is peaceful behavior and tolerance!

Islam wants to attack America's Christmas with fear akin to the same fear instilled by the historical attack on the United States of America on September 11, 2001. So-called not-so-extreme Muslims accept this position silently because they believe that Allah condones the extremists' actions and violent methods that have been used throughout the history of world islamization. Muslims are using the media, television, cable, internet, and global communications to destroy America's Christmas Day. They underscore their hate against Christians and this symbolical day by killing thousands of Christians around the world to show their disdain. However, the reality is that the number of deaths and threats has not slowed down the popularity of Christmas celebrations in the United States and the world. Although Muslims continue to spread death propaganda, Christmas still lives.

A prime and continuing example of Muslim Christian hatred is Iran, where Muslims are killing anyone who is a Christian or converted Christian because Muslims believe

such an action is blasphemy against Allah. Muslims attack Christians on Christmas Day to make a point that all people who have different beliefs will be executed or persecuted. The human right to choose one's own religion does not give families in Iran a right to make that choice to convert and still be alive after converting. The cost of being Christian or converting to Christianity in Iran or in any Islamic country is one's life. Muslims have banned any celebration of Christmas in Iran and other Muslim countries because the Islamic clerics and extremists in the government and outside the government have the undisputed control over the country.

In Kokkedal, Denmark in November 2012, citizens and political parties were afraid to put up a Christmas tree in fear of retribution from the local Muslims who do not believe Christmas belongs there.²² The primary Muslim naysayers in Europe and Iran are emulated by Muslim extremists like Abu Sayyaf in the Philippines, ISIL (Islamic State in Iraq and the Levant) in Iraq and Syria, Boko Haram in Nigeria, al-Shabaab in Somalia, and their off-shoots throughout the world. These Muslim jihadists celebrate with Christian killing parties and Barack Hussein Obama has no comment.

Between September 11, 2001 and December 1, 2014, there have been 1202 documented Muslim terror attacks against Christians.²³ The attacks include bombings, beheadings, burning of churches, slashing to death of Christian children and adults, as well as shootings or hangings without any remorse. This is hatred of human beings just because they believe in Christ and Christmas celebrations of the Birth of Jesus Christ. The Muslims try to strike fear in communities to make sure the population or local neighborhood cannot enjoy Christmas. Northwest Airlines Flight 253 was an international passenger flight from Amsterdam Airport Schiphol in Haarlemmermeer, Netherlands, to Detroit Metropolitan Wayne County Airport in Romulus, Michigan, United States. The flight was the target of a failed al-Qaeda bombing attempt on Christmas Day, December 25, 2009. Although four days later the National Council of Nigerian Muslim Organizations in the United

States of America (NCNMO) issued a statement condemning the attempted bombing of Northwest Airline flight 253 to Detroit, their statement is meaningless because it follows a doctrine of Islam called *al taqiyya* stating that Muslims can conduct any behavior whatever as long as the intent is the furtherance of Islam. ²⁴ This is the main reason why statements by any Islamist are not worth the paper upon which they are written or the air needed to breathe out their lies.

The attacks on Christmas by Muslims are warnings that the American way of life and Christianity are enemies of Islam. In November 2014, in Montgomery County School District, Maryland, Muslims forced the schools to abandon Christmas celebrations because these celebrations offended them and Islamic holidays were not on the school district's yearly calendar.²⁵

The Obamas did not want a Nativity Scene in the White House. They wanted to project their will on America that Christmas should be neutered, with no religious aspects. out islamophobia and the jihadis will stop killing,' and the band plays on. The slaughter increases. The genocide of Christians and religious minorities spreads. Towns fall. And the West watches and waits. And Obama clicks the heels of his red ruby slippers together three times and says, 'Islam is peace.'"³⁶

The POLDS Pounce on Christmas

POLDS are Progressives, Obots, Liberals, Dumbed-downers, Socialists-communists. It is December, the time of the year when POLDS somewhere attack Christmas daily with verbal vilification of God, Jesus, and the Cross.³⁷ They claim there is no God. They claim God is a myth. They claim Jesus was the first socialist. They argue Jesus was born in an occupied territory that is still occupied. became the dictator."⁴¹ If the reader does not understand by now, Christmas is the celebration of the Birth of Christ. POLDS have always been chopping off pieces from the American Traditional Christmas. Christmas should be politically correct. Evidently, the POLDS have character problems that can best be described as anti-social personality disorders. The POLD mantra is *What is good for me is good for you. If you think otherwise, you are wrong and you must be re-educated.* It is the same illogic as Islam! There is another technique used by the POLDS regarding the destruction of the American Christmas holiday. They use laws involving the *Constitution* to bring forth damaging accusations under the First and Fourteenth Amendments to attempt destruction within our own political system. The argument as far as the First Amendment to the *Constitution* is concerned is that which we encountered above regarding Thomas Jefferson's wall of separation metaphor. The reasoning behind using the Fourteenth Amendment to nullify Christmas is the statement that "No state shall make or enforce any law which shall abridge the privileges or immunities of citizens . . . nor shall any state deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws." POLDS argue that the presence of Christmas Nativity Scenes or Christmas trees, etc, abridges a citizen's privilege and that their presence does not provide citizens with equal protection of the laws.

As of this writing there are demonstrations in major cities such as Berkeley, Chicago, Miami, Washington, D.C., New York City, and Boston. In protest against the non-indictment of a New York City Police officer who allegedly caused the death of Eric Garner, an African American New York City resident, there are cries to "set that f**king tree on fire". As Evidently, race baiters do not want to realize or are incapable of realizing that Eric Garner was not choked to death by the New York City policeman, as they have asserted. The diabetic and grossly overweight Garner died of cardiac arrest in the ambulance, not strangulation at the arrest scene. The video does not show that he was confronted because business owners had called the police for help in keeping Garner from harassing their customers, that he was out of jail on bail from a previous arrest, that he was a felon who had been arrested 31 times, that the officer in charge at the scene was also black. celebrations for their vitriolic demonstrations because it is the time of the year that will assure them wide media coverage of their protesting.⁴⁵

The true intention of the POLDS is to convince Americans and the world that Christmas is evil by undermining the United States as a country founded on Christianity. In essence, this is the same modus operandi as that used by Muslim organizations in the United States of America and their creeping sharia movement. The underlying goal is to discredit the United States with misinformation, fear, and legal wizardry pointed at discrediting the Christmas foundation as coming from the Birth of Jesus Christ. Andrew Seidel, a lawyer for The Freedom From Religion Foundation sent the mayor, Bill Baker, a letter telling him that the theme "alienates non-Christians and others in Piedmont who do not in fact have a 'strong belief in prayers' by turning them into political outsiders in their own community." "The sentiment of 'Keeping Christ in Christmas' does not qualify as a secular celebration." Piedmont had to find a "more appropriate, more inclusive, and constitutional theme". The town changed the theme of the parade. The citizens marched carrying signs that read *Let's Keep Christ in Christmas*. Evidently, the participants in the Christmas parade did not protest against

the term *Xmas*, but were making statements that it is important to place emphasis on Christ's Birth, without which there is no salvation for the world.⁴⁸

The destruction of Christmas has been shirked as only propaganda that can never stop the delivery of the Christmas story and message in the United States of America. American atheists have reached their zenith of becoming involved in the separation of church and state controversy with the so-named *Wager of War on Christianity* Michael L. (Mikey) Weinstein, the founder of the Military Religious Freedom Foundation (MRFF) who has been engaged by the Pentagon to cleanse the United States military of all actions and references to religion.⁴⁹ Mr. Weinstein seems to have no qualms with Islam.⁵⁰ Yet, Islam continues to have more than qualms with the West, particularly at Christmas time when Christians all over the world are undertaking flights to their homeland so that they can be with their families.
