

HATE MATTERS¹

ETYMOLOGICAL BACKGROUND

The word *hate*, connotating psychological distress, derives from the Indo-European base forms **kād-*; **kōdes-*; **kōd-s-*.² From this source, the word occurs in the Proto-Germanic **Hatojanan* and appears in the Gothic *hatis*, *haten*, and *hatan*. In Old Icelandic *hate* appears as *hata*. In Old Saxon, it is *haton*. In Dutch, it appears as *haten*. In Old High German we encounter *hazzen*, the Modern German form being *hassen*.

The word *hate* appears as a form of *hateful*, *haters*, and *hated* 22 times in the *Beowulf Saga* in Old English as *hete* meaning *hatred* in ca. 725,³ and it appears four times sometime before 899 in *Pastoral Care* by Pope Gregory the Great (540-604, Pope from 590).⁴ In approximately 1175, *hate* appears as *haten* in the English common usage. The meaning of the word *hate* has not changed since ca. 1175.

The essence of *hate* is *abhorrence*, *detestation*, and *strong dislike*, all dealing with a person's or group's psychotic detuning.

Question: What does this etymological presentation tell us?

Answer: People who hate suffer from psychotic detuning and such people are the sources of hate because, to them, hate matters!

Nancy Pelosi and the Democrat Party

- **PLANNED PARENTHOOD:** Founded by the Socialist/Communist sympathizer and anti-Catholic Margaret Sanger and supported by Democrat Party politicians since 1975.¹² One of Margaret Sanger's goals was to rid the United States of Blacks through birth control. Bill Gates' father, William Henry Gates Sr., as a head of

Planned Parenthood, supported eugenics, the practice of controlling population with medicine and science so that undesirable people will be extinguished and only the healthy and strong will survive. Over 60 million babies have been aborted with the assistance of Planned Parenthood.¹³ But ... baby lives do not matter!¹⁴ Only the parts of the aborted fetuses matter to Planned Parenthood! The harvesting of aborted baby parts is a thriving source of income for Planned Parenthood.¹⁵

The KKK has gone through three stages of development:

First Klan: 1865-1871, number of members unknown.

Second Klan: 1915-1944, with between 3,000,000 to 6,000,000 members that peaked in 1924/1925.¹⁹

Third Klan: 1946-Present, with between 5,000 and 8,000 members.²⁰

After the Civil War, the 13th Amendment abolished slavery in the United States. Democrats from the Southern States reacted by legislating the vicious anti-Black Jim Crow laws.²¹ Already in 1866, Thaddeus Stevens, the Republican Representative from Pennsylvania (9th District), introduced legislation to guarantee former slaves “40 acres and a mule,” but Democrats were against it.²²

As a result of the history of the Democrat Party being involved in slavery and opposed to Blacks, Republican representatives led by Representative Louis Gohmert of Texas (1st District) has introduced a resolution condemning the politics of the Democrat Party regarding Blacks that the party be disbanded or be forced to change its name because of former slavery ties.²³ The first members of the United States African-American Congress after the Civil War were members of the Republican Party.²⁴

- WEATHER UNDERGROUND: Founded by Democrats and Communists at the University of Michigan. - ACORN: Association of Community Organizations for Reform Now. Active between 1970 and 2010, founded by Democrats. The organization has often been connected with voter fraud, which is still exercised in elections.²⁶
- OCCUPY WALL STREET: Founded by Democrats/Socialists/Communists in September 2011. The group protested against social and economic inequality, greed, corruption, and the influence of corporations and banks on government. It was the predecessor to the later Occupy Movement.
- CODE PINK: Founded by Democrats on November 17, 2002, by the Americans Jodie Evans (1954-20XX) and Medea Benjamin (1952-20XX). Code Pink is anti-Israel and pro-Iran and pro-Palestinian. Code Pink claims the region (Israel) has always been Palestinian.²⁷

A CONCENTRATED FOCUS ON BLACK LIVES MATTER (BLM)

On the night of February 26, 2012, George Zimmerman, aged 28, the neighborhood watch captain in The Retreat at Twin Lakes in Sanford, Florida, fatally shot Trayvon Martin, a 17-year-old African American high schooler. The shooting and the acquittal of Zimmerman by a jury in a court of law on July 13, 2013, led to radical protests across the United States.

A result of these protests was the formation of the Black Lives Matter movement (BLM) by the activists Alicia Garza, pro-Democrat Party, Patrisse Cullors, pro-Democrat Party, and Opal Tometi, pro-Democrat Party, on July 13, 2013. As of this writing, the BLM has over 30 chapters in the United States of America and has organized its global network.

Some critics say that BLM means Black Lies Matter. BLM does lie about the number of Blacks killed and the vast majority of perpetrators who are Black. The statistics tell the truth.³⁸

A subsequent investigation by the United States Department of Justice concluded with the department's announcement on February 24, 2015, that there was not enough evidence to prosecute George Zimmerman for a federal hate crime.

By limiting these constitutional freedoms and rights to Blacks, the BLM movement is actively conducting reverse discrimination.

2. Empathy

We are committed to practicing empathy; we engage comrades with the intent to learn about and connect with their contexts.

3. Loving Engagement

We are committed to embodying and practicing justice, liberation, and peace in our engagements with one another.

4. Diversity

We are committed to acknowledging, respecting and celebrating difference(s) and commonalities.

5. Globalism

We see ourselves as part of the global Black family and we are aware of the different ways we are impacted or privileged as Black folk who exist in different parts of the world.

6. Queer Affirming

We are committed to fostering a queer-affirming network. When we gather, we do so with the intention of freeing ourselves from the tight grip of heteronormative thinking or, rather, the belief that all in the world are heterosexual unless s/he or they disclose otherwise.

7. Trans Affirming

We are committed to embracing and making space for trans brothers and sisters to participate and lead. We are committed to being self-reflexive and doing the work required to dismantle cis-gender privilege and uplift Black trans folk, especially Black trans women who continue to be disproportionately impacted by trans-antagonistic violence.

8. Collective Value

We are guided by the fact all Black lives, regardless of actual or perceived sexual identity, gender identity, gender expression, economic status, ability, disability, religious beliefs or disbeliefs, immigration status or location.

9. Intergenerational

We are committed to fostering an intergenerational and communal network free from ageism. We believe that all people, regardless of age, show up with capacity to lead and learn.

10. Black Families

We are committed to making our spaces family-friendly and enable parents to fully participate with their children. We are committed to dismantling the patriarchal practice that requires mothers to work “double shifts” that require them to mother in private even as they participate in justice work.

11. Black Villages

We are committed to disrupting the Western-prescribed nuclear family structure requirement by supporting each other as extended families and “villages” that collectively care for one another, and especially “our” children to the degree that mothers, parents and children are comfortable.

12. Unapologetically Black

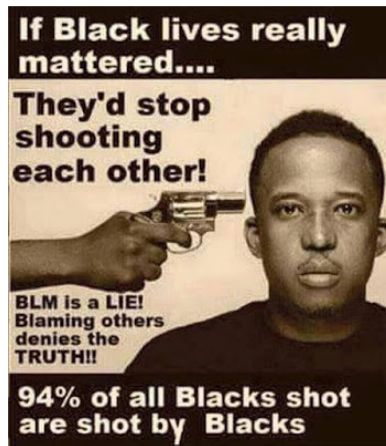

BLM has as one of its goals the conducting of war on police forces in American cities.⁴⁴ The Chairman of the Greater New York Chapter of BLM says,

"'We prepare to stop these murders by any means necessary.' Black Lives Matter leader declares war on police and group is 'training our people to defend our communities' in Black Panther style armed 'patrols,' and we are mobilizing our base,

The activist said BLM aims to develop a highly-trained 'military' arm to challenge police brutality head on in the wake of George Floyd's death in Minneapolis.⁴⁵

"It's our obligation, it's our duty to provide people with a way forward. We want the immediate end of government sanctioned (sic) murder by the police.

We prepare to stop these murders by any means necessary. We are preparing and training our people to defend our communities,' Newsome added

Newsome maintains that BLM will have "Peace Officers patrol black communities to challenge law enforcement and stop police brutality, reminiscent of the Black Panther Party."⁴⁶

Question: What is the significance of George Floyd's death?

Answer: George Floyd's death is the catalyst for the Democrat Party-supported rioters, vandals, demonstrators, destroyers, and America haters to show that, for them, hate matters.

November but he should resign now," she insisted. "Trump needs to be out of office. He is not fit for office."⁴⁸

"The domestic terrorist Joanne Chesimard, also known as Assata Shakur, is one of her main inspirations. Susan Rosenberg, a member of the board of directors for the left-wing Thousand Currents group, which handles the intake of donations made to Black Lives Matter, is a [convicted terrorist](#)."⁴⁹

"Cullors [said](#) that she and Garza are "trained Marxists" during a 2015 interview with the *Real News Network*, noting: "We are super versed on, sort of, ideological theories, and I think what we really try to do is build a movement that could be utilized by many, many black folk." Cullors [told](#) CNN's Jake Tapper in June that "Trump not only needs to not be in office in November, but he should resign now."⁵⁰

1. "Khan-Cullors said in a 2015 interview with Real News Network. 'Myself and Alicia in particular are trained organizers. We are trained Marxists.'

We are guided by the fact that all Black lives matter, regardless of actual or perceived sexual identity, gender identity, gender expression, economic status, ability, disability, religious beliefs or disbeliefs, immigration status, or location.

We make space for transgender brothers and sisters to participate and lead.

We are self-reflexive and do the work required to dismantle cisgender privilege and uplift Black trans folk, especially Black trans women who continue to be disproportionately impacted by trans-antagonistic violence.

We build a space that affirms Black women and is free from sexism, misogyny, and environments in which men are centered.

We practice empathy. We engage comrades with the intent to learn about and connect with their contexts.

We make our spaces family-friendly and enable parents to fully participate with their children. We dismantle the patriarchal practice that requires mothers to work “double shifts” so that they can mother in private even as they participate in public justice work.

We disrupt the Western-prescribed nuclear family structure requirement by supporting each other as extended families and “villages” that collectively care for one another, especially our children, to the degree that mothers, parents, and children are comfortable.

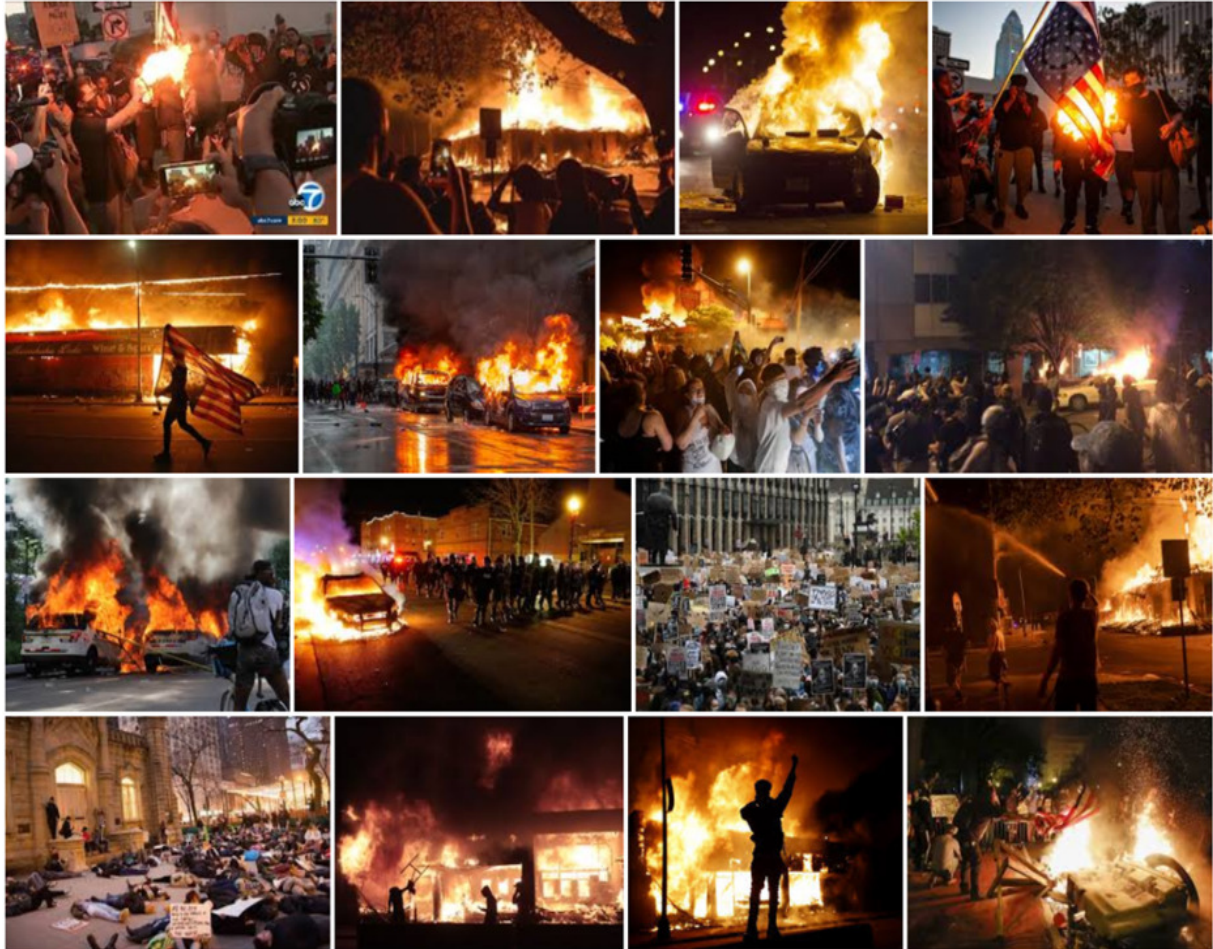

Black Lives Matter which is outlined in their charter.⁵⁶ Black Lives Matter is aligned with the BDS (Boycott, Divestment, and Sanctions against Israel and the Jews) Movement, and that should terrify every Jewish American."

The Black Lives Matter movement has gained significant momentum globally as millions of people protest the oppression of Black people by the police in the United States. However, this movement depicts a fundamental ideological weakness rooted in its belief that reparation can be achieved through racial exclusion. While the basis of the Black Lives Matter Movement is the universal principle that all individuals are equal, it fails to consider the value of the lives of other people around the world who are subjected to similar or even more gruesome forms of violence and oppression. The Black Lives Matter Movement does not raise concern for the lives of Black Africans subjected to acts of terrorism by Boko Haram, the Islamic terrorists in Africa. THE DESTRUCTION OF MONUMENTS AND STATUES

Protests over the killing of George Floyd have led to the removal of historical monuments and statues across the United States.⁶⁵ The periodical *Popular Mechanics*, founded in 1904, has published an article on how to demolish statues.⁶⁶ Even the *life* of the American flag is not secure,⁶⁷ except for its use as a memento for a dead criminal's brother, as was done when Nancy Pelosi presented Philonise Floyd a folded American flag after his testimony to the House Judiciary Committee on June 10, 2020. Such a presentation is usually reserved for a deceased military person's family for the deceased's patriotic service to the United States of America.

Many of the monuments and statues depict Christopher Columbus or Confederate leaders. Progressive activists, and others have often demanded their removal. Additionally, the Nancy Pelosi-led Democrats, who in Emancipation Hall on June 8, 2020, wore the Kente cloths that is a garb of former West African slave owners the Asante, or Ashanti, peoples of Ghana and Ewe peoples of Ghana and Togo,⁶⁸ would like to remove 16 statues from the Capitol that they consider to be racist. However, 14 of them are statues of racist Democrats.⁶⁹

Because of the outrage over the death of George Floyd, many protestors have taken matters into their own hands by vandalizing or tearing down the statues, and some state and city officials have taken official steps to order their removal. Below is a selected list of places where statues and monuments have been toppled, vandalized, or planned for removal by local government officials.

The list is not comprehensive because the destruction of monuments and statues is continuing.⁷⁰ It is a selection from the most recent update of July 31, 2020.

Albany, New York: Mayor Kathy Sheehan (D) said June 11 that she signed an executive order to [remove the statue](#) of Maj. Gen. Philip Schuyler from in front of city hall. Sheehan noted that Schuyler was reportedly the largest slave owner in Albany.

Birmingham, Alabama: Protesters toppled a statue of Confederate officer Charles Linn on June 2. Additionally, Mayor Randall Woodfin (D) agreed to remove an obelisk formally known as the Confederate Sailors and Soldiers Monument, [NPR reported](#).

Boston, Massachusetts: A Christopher Columbus statue [was beheaded](#) by protesters on June 10. The city later [removed the damaged statue](#). The city of Boston plans to remove the Abraham Lincoln statue.⁷¹

Chicago, Illinois: The George Washington statue in Washington Park was [found vandalized](#) on June 14. The statue could be seen spray-painted, and it had a white hood placed on its head.

College Station, Texas: A statue of Confederate general Lawrence Sullivan Ross [was vandalized](#) on the evening of June 9. The statue had been spray painted with the word “racist,” along with “BLM” and “ACAB.” The statue also had a rainbow-colored wig placed on its head.

Dallas, Texas: A Texas Ranger statue, named One Riot, One Ranger, [was removed](#) from Love Field airport on June 11. According to city officials, the decision was made by the Office of Arts and Culture and the airport.

Dearborn, Michigan: A statue of Orville Hubbard, the late mayor of Dearborn, was taken down on June 5. “Orville Hubbard—someone whose racist views should never have a place in our town—is one of those lessons for Dearborn,” Dearborn City Council President Susan Dabaja said in a [Facebook post](#).

El Paso, Texas: A statue depicting Don Juan de Onate was [vandalized on June 11](#). The statue is in the entrance of El Paso International Airport.

Fredericksburg, Virginia: A slave auction block [was removed](#) on June 12. The block was the subject of controversy in the city as the phrase “move that block” became a popular chant during the protests.

Huntsville, Texas: The Confederate monument in downtown Huntsville [was vandalized](#) by protesters on June 9.

Indianapolis, Indiana: On June 8, the city began [removing a monument](#) that memorialized Confederate prisoners of war. “Our streets are filled with voices of anger and anguish, a testament to centuries of racism directed at Black Americans,” Mayor Joe Hogsett (D) said in a statement. “We must name these instances of discrimination and never forget our past – but we should not honor them.”

Jacksonville, Florida: A Confederate statue [was removed](#) on June 9. Mayor Lenny Curry (R) [said he plans](#) to remove all Confederate monuments citywide.

Miami, Florida: Protesters [vandalized](#) the statues of Christopher Columbus and Juan Ponce de Leon on June 10, spray painting a hammer and sickle, Black Lives Matter fists, and more. A Statue of Jesus Christ was decapitated and knocked off its pedestal outside South-West Miami-Dade Church on July 15.⁷²

Louisville, Kentucky: A statue of John Breckenridge Castleman, a Confederate officer, [was removed](#) from a Louisville square on June 8.

Madison County, Alabama: The Madison County Commission [approved the removal](#) of a Confederate statue outside the courthouse in downtown Huntsville. The resolution stated that the statue will be relocated to “an appropriate location.”

Mobile, Alabama: Mayor Sandy Stimpson (R) [ordered the removal](#) of a statue depicting Confederate Admiral Raphael Semmes on June 4. The statue was removed the following day and placed in “a secure location,” Stimpson said.

Montgomery, Alabama: A statue of Robert E. Lee was [torn down](#) by four protesters at the high school of the same name. The protesters were originally charged with the first degree of criminal mischief, however the charges were dropped on June 11.

Mount Pleasant, South Carolina: On June 3, police found a monument in a historic Confederate Cemetery [vandalized](#). Several symbols were spray-painted on the monument, such as a swastika and “USA” written on the side.

Nashville, Tennessee: A statue of politician Edward Carmack was toppled on May 30 outside the state Capitol, [The Associated Press reported](#). Carmack was known for criticizing the writings of Tennessee civil rights journalist Ida B. Wells.

Norfolk, Virginia: A Confederate monument [was vandalized](#) on June 8. Mayor Kenny Alexander (D) [announced](#) that part of the monument will be removed.

Oxford, Mississippi: A [Confederate monument](#) at the University of Mississippi was allegedly vandalized by a public school teacher on May 30. The words “spiritual genocide” were spray-painted on the statue along with red handprints.

Philadelphia, Pennsylvania: A statue of the late Mayor Frank Rizzo [was removed](#) on June 2. "The statue is a deplorable monument to racism, bigotry, and police brutality for members of the Black community, the LGBTQ community, and many others," Mayor Jim Kenny (D) said.

Pittsburgh, Pennsylvania: A statue of Christopher Columbus was [vandalized on June 12](#). It was reportedly vandalized multiple times before the recent protests.

Portsmouth, Virginia: Protesters beheaded four Confederate statues on June 10. Police did not step in to stop the vandalism as "such action would have required force which would have escalated the event," Mayor John L. Rowe (I) [said in a statement](#). "We can repair a monument, but we cannot bring back a life."

Providence, Rhode Island: A school teacher and two others were arrested after they [allegedly vandalized](#) a statue of Columbus on June 13. All three suspects were charged with desecration of a grave/monument and conspiracy.

Raleigh, North Carolina: Protesters [vandalized](#) a Confederate statue at the state Capitol on June 10. The group, known as Raleigh United, has since added a golden plaque honoring George Floyd.

Richmond, Virginia: Protesters took down three statues in Richmond. [On June 6](#), a statue of Confederate Gen. Williams Carter Wickham was toppled by protesters. [On June 10](#), a statue depicting former Confederate President Jefferson Davis was torn down. [That same day](#), a statue of Christopher Columbus was taken down and thrown into a nearby lake.

Rocky Mount, North Carolina: The city council [voted to remove](#) a Confederate monument on June 8. The city plans to remove more Confederate monuments.

Sacramento, California: State lawmakers [announced on June 17](#) that statues of Christopher Columbus and Queen Isabella would be removed from the Capitol rotunda. "Christopher Columbus is a deeply polarizing historical figure given the deadly impact his arrival in this hemisphere had on indigenous populations," Senate President Pro Tempore Toni Atkins (D), Assembly Speaker Anthony Rendon (D) and Assembly Rules Chairman Ken Cooley (D) said in a joint statement.

Saint Paul, Minnesota: Protesters tore down a statue of Columbus outside the state Capitol. [A video](#) shows protesters wrapping a rope around the statue's neck and pulling it down.

Sharpsburg, Maryland: The Robert E. Lee statue at Antietam National Battlefield and "Old Slave Block" in the town [were vandalized](#) on June 2.

In San Francisco's 2nd Congressional District, represented by the Democrat Party Congressman Jared William Huffman, the Francis Scott Key statue was toppled and pulled down in Golden Gate Park, San Francisco, California, on June 20, 2020.⁷³ As of this writing, Mr. Huffman has not commented on this destruction. This is not unusual because hate itself is destructive. Mr. Huffman's credibility is thus destroyed. That is the reason why Democrats are destroyers of American heritage, culture, and principles. The Democrat Party is absurd.

However, The following statue will not be toppled and destroyed because it is the great symbol of evil and hate that BLM and the Democrat Party and its affiliated organizations support.

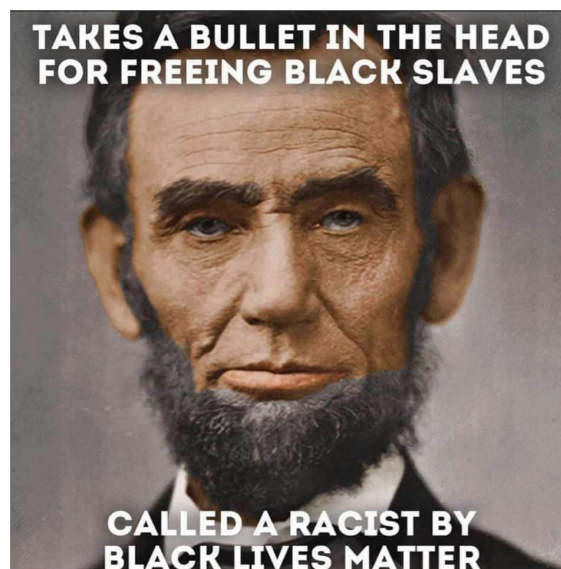

Moreover, “George Soros funds the virulent anti-Israel, pro-BDS ([Boycott, Divestment, and Sanctions](#) movement, that includes people and organizations affiliated with Palestinian terrorist groups, such as the Popular Front for the Liberation of Palestine ([PFLP](#)). The PFLP is a U(nited)S(tates)-, E(uropean) U(nion)-, Canada-, and Israel-designated terrorist organization.”⁸¹

13, 2020. George Soros's Open Society Foundation is doling out 220 million dollars to 'Dismantle Systemic Racism' in the United States of America. However, systematic racism does not exist in America outside the parameters of the Democrat Party.⁸³

research, paralyzes media and police, hampers public safety, harms minorities, leads politicians astray, and manipulates the voting public."⁸⁶

Question: What does George Soros' involvement in anti-American organizations tell us?

Answer: George Soros is the financier of hate matters!

BLACK LIVES DO NOT MATTER IN ISLAM. ONLY HATE AND THE SPREADING OF ISLAM MATTER

We are living daily with the phrase *Do Black lives matter?* The phrase is racist because the present violent protest emphasis is on Black lives. There is no protesting against the murder of Blacks in Africa. They are killed every day by Muslims obeying the commands of Allah and Muhammad set down in the Koran and the Sunnah, the quasi-documented, collected sayings and teachings of Muhammad.

throughout the world be slaves to Islam. Slavery and, indeed, the slaying of Jews, Christians, and other unbelievers is okay because it is a so-called religion that requires such evil. Slavery controlled by Pakistani Muslims is alive and doing well in the United Kingdom.⁸⁹

Islam demands respect. But Islam has always destroyed cultures and heritages that it supplanted or wished to replace. The *cult of Islam* does not deserve respect!

Non-Muslims should demand that Islam ask for forgiveness for all of the racism that comes from Muhammad and the Koran.⁹⁰

Quarter them to pass the time; (Faye's Comment: "Surely, this is all just irony and not to be taken seriously, right? Let us, however, continue with our charming reading experience.")

Whip them hard, and do so earnestly (Faye's Comment: "These are just rap lyrics, what are you getting at, anyway? There's nothing bad there.")

Let it all reek of death, let them piss blood; Let these foul fruits provide us with a fascinating, pallid, and entertaining spectacle (Faye's Comment: "How entertaining indeed, wow! Are we having a good time or what!")

Take any life they have, let them be lifeless objects from now on (Faye's Comment: "Oh, because the bloke is in a hurry, in a hurry to kill us right now! But wait, it's a song, just a song, so don't panic!")

Dominate them, and put your names on their testaments!

Chorus: ***Hang them, hang them, hang the Whites!***

No feelings, let them all die at the same time! (Faye's Comment: "A genocide — why not? Let us unleash our insanity!")

Set an example, torture those too rebellious in front of your whole group.⁹²

Guillaume Faye continues his assessment by on-target irony.

"What are dictionaries just because the dominant ideology and those who gobble it up so blissfully find it too disagreeable? Do you know what is really unpleasant, by contrast? Living your life surrounded by ten million, twenty million, or even a greater number of Africans and Arabs (who are Muslims), with whom we

have never wanted to associate. (*I add: and who do not want to assimilate into our society and culture!*) What is very disagreeable indeed is acknowledging the thought that, soon enough, (we) will be a minority in (our) own lands. What is more than unpleasant is our inability to describe the very horror of our situation without burdening our statement of the facts with foolish periphrases and politically correct words, all of which remain less expressive of what is crucial for us to say than of what one is required to say.

We have been invaded by immigrants belonging to foreign and belligerent races that have come here to have their cake and eat ours. They want to reap the benefits of Western prosperity without having to make the same effort we have made in order to enjoy it, while simultaneously retaining their own identity and hating us most openly. They perceive us as being foreign and will continue to do so; it thus seems fair to me that we should regard them in the same manner. I use the word race because I do not see how it would ever be possible not to label as racist the lyrics of this rap song, which was released in 2018.

Who would dare to claim that these lyrics, written and sputtered by a black man (Nick Conrad — a pseudonym, of course), are not racist?"⁹³

Islam is a religion that demands respect, as evidenced in its efforts to convert provinces, states, and entire regions into Muslim caliphates. Despite its demand for compliance, Islam perpetuates racism, hate, and violence in many forms. Its demand for respect stems from its belief and strict adherence to Sharia Law. Sharia Law forms the fundamental pillars of Islam, and it is derived from two primary sources: the Koran and Sunnah. One of the significant aspects of the Koran and the Sunnah is their

indoctrination of violence in various levels of society, including the family, civil government, social relationships, and (cultural) war.

While the major religions of Judaism, Christianity, Hinduism, and Buddhism have historically expanded through the use of political pragmatism, Islam has grown by means of violence, threats, and war, as required by the Koran and the Sunnah, the two primary sources of its propaganda. The Koran and the Sunnah are based on the belief that war is justified under certain circumstances, especially in its religious form: *Jihad*.

Jihad refers to the duty of Muslims to maintain the religion of Islam through every means, including violence and war. Through *Jihad*, Muslims have justified violence against those perceived to be nonbelievers. The wordings and definition of Jihad in the Koran and the Sunnah, inherently incite its followers to a lifestyle of terrorism as they are expected to engage the perceived enemy actively using all methods possible. Using the tenets of *Jihad*, Muslims have caused the deaths of up to one billion people across the globe, especially in Africa and Israel.

Following in the footsteps of the prophet Muhammad, radical Islamic groups, such as the Taliban, AL Qaeda, Al Shabaab, Boko Haram, and most recently, the Islamic State of Iraq and Syria (ISIS), have continued the doctrine of conducting raids when executing *Jihad*. During these raids, the *mujahedeen*, or the people engaged in *Jihad* give themselves the religious right to loot and take from the enemy whatever they so, please. In this context, the demonstrations by BLM, Antifa, and kindred organizations, ad hoc or not, are no different.

Part of such looting involves the rape of women and young girls even in the childhood age! Islamic law does not forbid a married man from having sex with a slave girl, whether intercourse is consensual or not. Using this tenet of *Jihad*, *mujahedeen* often capture women and girls from territories which they raid and subject them to horrendous acts of sexual violence, some of which include group rape.

Because Islam does not acknowledge the rape of a slave girl, no justice is sought or provided by Sharia Law. Some of these women die from the physical and emotional trauma they suffer at the hands of the *mujahedeen*. Survivors of these acts of sexual violence are left with the significant lifelong psychological trauma that affects the quality of life.

Where are the Antifa and BLM protests?

Apart from mass genocide, rape, and child-molestation, *Sharia Law* permits and encourages the practice of slavery by Muslims. While the practice of slavery is rooted in human history as a practice by many different groups, Muslims have historically perpetuated this practice and promoted its growth and expansion. The historical slavery of Black people from Africa is mainly attributed to Muslims who are predominantly located in North and West of Africa. The growth and expansion of slavery are primarily connected to the slave trade that was dominated by predominantly Islamic cultures.

Where are the Antifa and BLM protests?

In the past five years, the escalation of war and violence by ISIS and Boko Haram in Syria and Nigeria respectively has revealed killings⁹⁴ and the hidden practices of slavery that Muslims have maintained for many centuries. ISIS and Boko Haram have developed the method of capturing women and girls to keep them as sex slaves.

Where are the Antifa and BLM protests?

ISIS, (Islamic State of Iraq and the Levant [ISIL], also known as the Islamic State of Iraq and Syria [ISIS]), officially known as the Islamic State [IS], and by its Arabic acronym Daesh, is a militant group that follows the Salafi jihadist teachings of Sunni Islam, the [fundamentalist](#), [Salafi jihadist](#) doctrine of [Sunni Islam](#). Boko Haram, meaning in English *Western education is forbidden*, follows this course, and it has developed the practice of capturing women and girls to keep them as sex slaves.

Where are the Antifa and BLM protests?

The students at the Government Secondary School for girls in Chibok, Nigeria in April 2014 were prepared to take their final exams when at circa 11 p.m. on April 14, trucks of militants from Boko Haram, forced 276 girls from their dormitories onto trucks and drove into the Sambisa forest, a nature reserve that the jihadist group controlled

and from where it operated its bloody war against the Nigerian government. The kidnapped women and girls were held as prisoners for more than three years.⁹⁵ Boko Haram has taken the practice of slavery to the next level by developing an illegal market where fellow Muslims can purchase slaves, both male and female, regardless of age, at a set price rate. Islam encourages not only violence and war but also draconian dark-age-type practices that are outdated and will always be outdated by the development and spread of democratic republicanism globally.

Where are the Antifa and BLM protests?

SLAVERY DOES NOT MATTER IN ISLAM, AND NEITHER DOES BLACK LIVES MATTER.

A Muslim will adamantly claim that Muhammad was an abolitionist and freed slaves and likely declare that slavery does not exist in Islam because the word does not occur in the Koran. Allah never mentions the word slavery. Superficially the contentions are correct. However, slavery is discussed with the euphemism *persons whom the right hand possesses*. The expression *ma malakat aymanukum* and its variants are the Arabic expressions used in the Koran to refer to slaves. They are found 15 times in Koranic verses.⁹⁶

Of course, Muhammad is not at fault! Slavery is allowed by Allah! Muslims cannot be slaves because the Koran 3:110 declares that Muslims are the best people in the world created by Allah. Slavery status is reserved for non-Muslims. Some examples of Allah-ordained slavery are here: [Koran \(2:178\)](#), [Koran \(4:24\)](#) and [4:92](#)), [Koran \(8:69\)](#), [Koran \(16:75\)](#), [Koran \(23:5-6\)](#), [Koran \(24:32-33\)](#), and [Koran \(33:50\)](#).

Even Muhammad's child wife, Aisha, said, "*I noticed that the Messenger of Allah was missing from bed... I thought he had gone to one of his concubines*" because she thought that Muhammad had gone to one of his female slaves for sex.⁹⁷

Ibn Ishaq (693) - "Then the apostle sent Sa-d b. Zayd al-Ansari, brother of Abdu'l-Ashal with some of the captive women of Banu Qurayza to Najd and he sold them for horses and weapons." Muhammad trades away women captured from the Banu Qurayza tribe to non-Muslim slave traders for property. (Their men had been executed after surrendering peacefully without a fight).⁹⁸

The *Umdat al-Salik*, known by its English title *Reliance of the Traveller*, is the codification of Islamic Law. Muslims refer to it as the Sacred Law or Sharia Law of the Shafi'i school of Islamic Jurisprudence (*fiqh*), codified in the mid-14th century. This Sharia law says that when a child or woman is captured by Muslims, they become slaves for the simple reason that they are captured by Muslims.⁹⁹ A female prisoner's previous marriage is immediately canceled, and her position is that her new Muslim owner can use the woman and/or child as a sex slave. It is a myth (a lie) that Islamic slavery was not racial. The opposite is true. It was extremely racial. Muhammad called African slaves that Muslims possessed raisins-heads¹⁰⁰ and pug-nosed slaves.¹⁰¹

The caliph Umar (Muhammad's father-in-law), declared that Arabs should not be taken as slaves.¹⁰² Therefore, to obtain slaves, Islamic campaigns were undertaken to capture slaves in Africa, Europe, and Asia for import to the Middle East. The slaves from Europe were referred to as *white gold*.

869-883: The Zanj Rebellion was/is the most massive slave rebellion in human history that took place in Basra, Iraq. Half a million African slaves staged a brave uprising against their Arab-Islamic masters that lasted fifteen years before being brutally crushed.¹⁰³

Since the ninth century and into the twenty-first century, millions of Christians have been captured into slavery by the jihadists of Islam. The Turks were famous slave traders. They were so pervasive that the word *slave* in English comes from the Turkish-Slavic word *slav*. Muslim slave robbers operated in the north of England, Ireland, and Scotland.

In the 21st century, we encounter these references based on Islamic justifications for slavery:

- 2003: A minister in Saudi Arabia's highest religious body said: "Slavery is part of Islam. Slavery is part of Jihad, and Jihad will continue as long as Islam exists. Those who argue that slavery has been abolished are ignorant, not scholars. They are just writers. Whoever says this is an unbeliever."¹⁰⁴
- 2011: Salwa Al-Mutairi, who is considered a women's rights activist in Kuwait, suggested that Russian women be captured in battle and made sex slaves to prevent Muslim husbands from committing adultery.¹⁰⁵
- 2014: After the Islamic State kidnapped thousands of Yazidi women and children and forced them into slavery, the caliphate issued a kind of FAQ on slavery, which contained rules for the sexual harassment of children: *"It is permissible to have intercourse with the female slave who hasn't reached puberty if she is fit for*

intercourse; however, if she is not fit for intercourse, then it is enough to enjoy her without intercourse." The best that "mainstream" apologists could find in response to this was a letter that appealed to "the reality of today," which means that Islam has no fixed moral position on the rape of women and children after their capture.¹⁰⁶

➤ 2014: The most prestigious university in the Islamic world, al-Azhar University in Cairo, Egypt, announced that Muslims in the course of a battle could capture women for sex slavery. Suad Saleh, a so-called "moderate" woman, who said the statement at the same time that thousands of Yazidi women were being cruelly raped by the Islamic State.¹⁰⁷

➤ 2015: A Quran memory contest offered slaves as the first three prizes. There were no Muslim protest voices from anywhere else. As Uzy Bulut said sharply: *"A religion that encourages destructive riots and cartoon killings but shows no signs of mourning as little girls are sold and raped does little to advance civilization."*¹⁰⁸

➤ 2015: A 12-year-old girl captured by the Islamic State said that her "Lord" would pray before raping her: *"He told me that Islam allowed him to rape an unbeliever. He said by raping me he was approaching Allah "*¹⁰⁹

➤ 2015: Slaves of the opposite sex were forced to pray before the rape or to recite passages from the Koran. When a Yazidi woman asked a member of the ISIS caliphate not to rape a little girl, he replied: *"She is a slave ... and sex with her pleases Allah."*¹¹⁰

➤ 2016: A scholar at the Egyptian al-Azhar University, the most respected Islamic school in the Sunni world, said that non-Muslim women could be captured in time of war, *"owned,"* and raped *"to humiliate"* them.¹¹¹

- 2017: A Kuwaiti sheik called the enslavement of unbelievers "one of the virtues of Islam". There is also a modern fatwa that advocates the sexual abuse of non-Sunni women in Syria.¹¹²
- 2017: African slaves were freed from captivity in Libya, where their Arab masters not only raped and starved them but also forced them to drink from toilets. *"Groups like CAIR, who claim to be concerned with" human rights "have never lifted a finger to help them."*¹¹³
- 2020: An American Islamic apologist defended slavery, saying that "renting" labor "is better than owning."¹¹⁴

Question: What does the position of Islam regarding Blacks and non-Islamic cultures tell us?

Answer: Islam hates them because hate matters!

Sonia Elks reports a study by the Thomas Reuters Foundation that slavery is also doing well in at least 94 countries in the world that have not legislated laws making slavery a crime and outlawing it. A majority of them are Muslim countries. Elks continues, "More than 40 million people are held in modern slavery, which includes forced labor and forced marriage, according to estimates by the International Labour Organization and the anti-slavery group the Walk Free Foundation."¹¹⁵ As of this writing, slavery exists and is doing well in Muslim countries.¹¹⁶ The epitomé of

hypocrisy is that Mauritania, which is known to have 500,000 black slaves within its borders, is presently on the United Nations Human Rights Council .¹¹⁷

CLOSING STATEMENT

and philosophy that deserves utmost respect is ALL lives matter. A shift in focus to a doctrine that *all lives matter* offers better prospects for social and economic development.

Emphasizing the value of every life will help yield the desired social change that would lead to equity in society on a national, regional, and global scale.

A final statement concerning Islam, Jews, and slavery is given by former Muslims who have become apostates.

His institution of slavery as a divine order of society was one of the worst curses that could happen to humanity. Allowing sex with slave-girls made (the curse) worse. His trading of slaves, such as selling some Banu Qurayza captives in Nejd, was another evil institution.

Muhammad engaged in all these cruel, dehumanizing, and horrible acts with the divine sanctions of (his created) Allah. Muhammad and his brainchild Allah were the worst evils to befall humankind, the detriment of which continues to afflict humanity with no end in sight."¹¹⁹

For BLM, which is supported by the Muslim Brotherhood,¹²⁰ only Black lives that hate matter. For Islam, only Muslims who hate non-Muslims matter. Black Muslims
