HEY, LET'S PUT ON A SHOW!

OPENING STATEMENT

The show that is being put on is not good. It smells of socialism/communism and Barack-Hussein-Obama-controlled fools.

Some readers may remember the let's-put-on-a-show theme of the late-1930 movies with Mickey Rooney and Judy Garland. Some other readers may remember these films as re-runs on some television movie-cable stations. Mickey Rooney, Judy Garland and their friends cleaned up the old barn, put on a show and charged admission to raise money for some definite purpose, usually a charity. That was good old capitalism: invest time, effort, make money with a profit, and put it to positive, moral use.

The show to which this author is referring has been staged for almost two months, since September 11, 2011 at Zuccotti Park in New York City. The goal, however, is different. The scumbags in the Occupy Wall Street movement are not the creative persons that Mickey Rooney and Judy Garland, as well as the other actors and actresses were in their put-on-a-show movies. The rabble at Zuccotti Park has the goal of destroying capitalism for good. The parasites would like nothing better than to destroy the United States banking system, have Barack Hussein Obama's government take care of them forever, and not require that they ever work for a living. Moreover, Barack Hussein Obama and the canaille sympathizers with the Democratic Party, as well as some riffraff within that political party are avid supporters of the park parasites and their related occupy movements that have taken place in other cities across the United States of America. THE BACKGROUND

In 1998, the commercial bank holding company Citicorp merged with the Travelers Group insurance company and renamed themselves Citigroup. The new mega conglomerate thus combined banking, insurance services, and security services under one concern that included Citibank, Primerica (a marketer of financial packages and services), Smith Barney (a retail brokerage firm), and Travelers Group (according to its market value the largest American insurance corporation). The action violated the Glass-Steagall Banking Act of 1933 and the Bank Holding Company Act of 1956. Nevertheless, in September 1998, the United States Federal Reserve under the chairmanship of Alan Greenspan provided Citigroup with a waiver that allowed them to keep their status an illegal organization.¹

In 1999, the Glass-Steagall Act was repealed by the Gramm-Leach-Bliley legislation (Financial Services Modernization Act of 1999) that was signed into law by President William Jefferson Clinton on November 12, 1999.² The Glass-Steagall Act had provided for barriers in the banking market, securities companies, and insurance companies; namely that no one institution could act as a combination of an investment bank, a commercial bank, and an insurance company. The Gramm-Leach-Bliley legislation allowed commercial banks, insurance companies, investment firms, and securities companies to consolidate and combine these services, in the case of Citigroup, retroactively.³

It did not take long for cigar-wielding President Clinton to lower the required financial reserve of the Federal National Mortgage Association (Fannie Mae) to 2.5%,

thus making it possible for Fannie Mae to guarantee/purchase \$97.50 in a mortgage for every \$2.50 it had in residual value beyond any mortgage thereon and liability therein to cover the bad debts. The result was that if more than 2.5 percent of the loans were bad, the taxpayers would have to pay for them. Important additional ingredients were the Saul-Alinsky-type demands on banks under President William Jefferson Clinton – when he was not enjoying a cigar in the Oval Office – and the unwillingness of representative Barney Frank (D-MA) and former senator Christopher Dodd (D-CT) to provide controls for the banking industry, namely Fannie Mae and the Federal Home Mortgage Corporation (Freddie Mac), which were and are nothing more than money lenders to people who want(ed) a house, but do/did not have the money to buy one and never would have that money. The Frank-Dodd financial idiocy, coupled with the economic dilettanti of the Democratic Party that controlled Congress during the last two years of President Bush's administration, paved the way for so-called banking schemes to provide sub-prime loans for homes to poor people who could never pay off the loans.

The logical question is why did the banks even make such risky loans? The logical and only answer is that the Clinton administration applied political and economic pressure, as well as legal threats to force banks to help fundamentally insolvent people become homeowners. The Department of Justice threatened to file lawsuits against the banks with beginning fines of \$10,000 per bank loan application, particularly when the banks redlined (made a discriminatory notice on the loan). In addition, Barack Hussein Obama's criminal community service organization, Association of Community Organizations for Reform Now (ACORN) used Saul Alinsky methods and the Cloward-Pliven strategy on the banks to force them to make the sub-prime loans.⁴ Saul Alinsky was and is alive and well!

The mortgages that Fannie Mae and Freddie Mack purchased and guaranteed were/are still backed by the federal government, i.e., the taxpayers. These loans were then sold to large investment banks that bundled them in non-transparent economic

packets and sold the mortgages risk-free all over the world, accompanied by large fees which the investment banks pocketed. That is the key to the bank bailout in 2008-2009. The government did not pay the banks for the bad loans. The taxpayers did, thanks to the crisis caused by William Jefferson Clinton with later support from Barney Frank and Christopher Dodd and the Senate Democrats in the eight years of the George W. Bush administration, and the president putative president Barack Hussein Obama.

President George Walker Bush tried to reform Fannie Mae and Freddie Mac seventeen times during his eight-year administration. At the beginning of President Bush's administration in 2001, information was released to the administration by whistle blowers that the accounting books at Fannie Mae and Freddie Mac had been manipulated, namely by the Clinton appointees James Johnson and Franklin Raines, James Johnson deferred \$200 million in Fannie Mae expenses and received a self-implemented bonus of \$21 million dollars in addition to his accumulate earnings at Fannie Mae totaling \$200 million.⁵ Both Johnson and Raines became very wealthy by giving themselves huge bonuses as a result of Fannie Mae and Freddie Mac making tremendous (false) profits. By 2006, Franklin Raines was forced out of Fannie Mae after evidence of malfeasance showed that he had given himself \$90 million dollars worth of salary and bonuses based on false financial transactions that showed how *profitable* Fannie Mae had become.⁶

These two Democrat thieves, along with a third Democrat thief, Tim Howard (a Fannie Mae embezzler) are the three people the occupiers of wall Street should be protesting against, and not the Wall Street bankers. However, Raines, Howard, and Johnson are safe because they are all economic advisors to Barack Hussein Obama, who is protecting them from the mob of protestors.⁷

In 2005, Senator John McCain (R-AZ) tried reform Fannie Mae and Freddie Mac with proper legislation.⁸ However, Senate Democrats were able to block the reform legislation in committee, thus causing it never to come to a vote in the Senate.

When the Democrats won a majority of seats in the House of Representatives and the Senate in 2006, they assured the American public that there were no problems with Fannie Mae and Freddie Mac. They were supported in their opinions by the Senate Banking Committee Chairman, Democrat Christopher Dodd and the House Banking Committee Chairman, Democrat Barney Frank. Both were responsible for overseeing Fannie Mae and Freddie Mac.

In 2010, the Dodd-Frank Financial Reform Bill was signed into law by Barack Hussein Obama.⁹ In essence this legislation covered up the machinations of George Soros in the bank crisis in 2008-2009. George Soros is the most important and most influential member of the Management Funds Association (MFA). George Soros, a hedge fund short seller, financed Barack Hussein Obama's presidential election campaign in 2008 and he engineered the economic meltdown in 2008. The Senate Financial Crisis Report, 2011, states that the financial crisis of 2008-2009 "was not a natural disaster, but the result of high risk, complex financial products; undisclosed conflicts of interest; and the failure of regulators, the credit rating agencies, and the market itself to rein in the excesses of Wall Street."¹¹ Of course, Wall Street was at fault. Yet, the bankers were doing only what William Jefferson Clinton had allowed them to do and what the Democrats did not want to stop them from doing, thus resulting is the fact that almost one-third of all mortgage loans in the United States of America are in a state of default.

When the prices for houses reached their zenith in 2005-2006, the mortgage bubble began to explode, which has resulted in the fact that approximately 23.1 percent of all mortgage loans in United States are underwater. This means that the home owners are in default. The total is expected to exceed 30 percent by the end of 2011. Historically, mortgage default averages fluctuate between 0.25% and 2%.¹²

bonuses and explain to the American people, the taxpayers who bailed out Freddie and Fannie, why he continues to reward failure.” Not much will come of Senator Barrasso's complaint because Barack Hussein Obama is a law-abiding person and surely Barack Hussein Obama will not take action against the provisions of the Dodd-Frank bill, which, by the way, do not apply to Fannie Mae and Freddie Mac.¹³

discovered video – filmed by Occupy Wall Street supporters themselves – reveals that New York Times reporter Natasha Lennard is not merely covering the protests, but is also apparently taking part in planning and executing them. In the video, Lennard is seen participating as a featured speaker in a discussion among anarchists, communists, and other radicals as they examine the theory, strategy and tactics of the Occupy Wall Street protests.” Natasha Lennard “was arrested along with seven hundred activists on the Brooklyn Bridge on Oct. 1. When Lennard reported on her arrest at the time, she appears to have concealed her own apparent role in the Occupy Wall Street protests, implying that her arrest was an abuse of press freedom. She used her affiliation with the Times to win her early release.”¹⁶ Although Natasha Lennard's conduct is a kind of scamming, the truth behind the realm scam is that there are bankers on Wall Street who cannot be separated from Barack Hussein Obama and vice-versa. With such supporters, who needs enemies? Enemy number one is the fourth on the list!

On October 30, 2011, ConservativeByte.com reported that the o-so-innocent-and-idealistic-Occupy-Wall-Street movement has “a reported \$500,000 on deposit.” “(A) radical group called the Alliance for Global Justice is legally sponsoring the protest. By lending its tax-exempt status – for a 7 percent cut! – the global-justice group allows donors to deduct their contributions from federal taxes and gives its own board control over the money. The alliance, based in Washington, is a hotbed of far-left causes that range from backing hunger strikes in California prisons to denouncing the CIA and oil

companies. Its Web site says the group sponsors operations in the Gaza Strip, with Hamas, and boasts of an alliance with Anarchists Against the Wall, which contests Israel's security barrier in the West Bank. The group suggests it has a relationship with Iran, supported the Sandinista revolution in Nicaragua and expresses solidarity with Venezuela's Hugo Chavez against the United States." *This innocent, idealistic, charitable, humane-oriented organization* "also offers 'activist training'—which is like job training without an actual job."²⁰

Another important participant in the Occupy Wall Street movement and the inter-connections which the occupier-Obama-fools do not comprehend are the American Federation of Labor – Congress of Industrial Organization (AFL-CIO) and the affiliated Working America. Cliff Kincaid points out that Working America is "headed by a veteran of the Venceremos Brigades to Cuba, a progressive activist by the name of Karen Nussbaum. Equally significant, her husband works for the public relations firm that (at one time) represented billionaire hedge fund operator George Soros. The Venceremos Brigades, which are actually still in operation, were the orchestrated 'tours' of the communist island, conducted under the authority and supervision of Castro's intelligence service. They were designed to create a communist cadre on the soil of the United States. The Brigades were organized in 1969 by Bernardine Dohrn and other members of the Weather Underground terrorist group." Karen Nussbaum is a personal friend of Jane *Hanoi* Fonda. Karen Nussbaum has stated that she is "impressed with Castro and with Cuban socialism." "Another traveler to the communist island was Kathy Boudin, a member of the Weather Underground who had also been to Moscow. Kathy Boudin, Cathy Wilkerson and Ted Gold, two other Weather Underground members who had been to Cuba, had established a bomb-making factory in a New York City residence in 1970 when one of the bombs went off, killing Gold and Weather Underground members Diana Oughton and Terry Robbins. Boudin and Wilkerson managed to escape. The bomb

was intended for an officers' dance at Fort Dix, New Jersey."²¹ Don Fredrick of *The Obama Timeline* reports that "Boudin and her husband David Gilbert are serving three consecutive 25-year prison terms for the killing of three Brinks guards in a 1981 robbery meant to fund their Weather Underground, Students for a Democratic Society, Black Liberation Army, and Black Panther Party activities. Their son, Chesa Boudin, was adopted by Bernardine Dohrn and William Ayers – who hosted the initial political event for Obama that led to his being elected to the Illinois State Senate. Both William Ayers and Chesa Boudin serve on an education advisory board of Venezuelan socialist President Hugo Chavez."²²

An occupy movement cannot demonstrate if it does not have anything to occupy. Why not use Zuccotti Park? There is a reason for this decision. The sub-surface connections are more than interesting. 2. Granite Reliable Power is constructing a wind farm in Coös County, New Hampshire.
3. Granite Reliable Power is a wholly owned subsidiary of Brookfield Asset Management via Brookfield Renewable Power.
4. One week before operation Occupy Wall Street started, the Department of Energy gave its permission for a \$128 MILLION federal loan to Granite Reliable Power.
5. On the morning of October 14, 2011 Brookfield Asset Management was going to send in cleaning crews to Zuccotti Park, but the cleaning crews were told to stand down by New York's Mayor Bloomberg.
6. Bloomberg's live-in mistress, Diana L. Taylor, has a 75% stake in Granite Reliable Power and she is an executive on the Board of Directors of Brookfield Properties with John E. Zuccotti. Diane L. Taylor is also a director of the Federal National Mortgage Association, also known as Fannie Mae, which has been continually bailed out by Barack Hussein Obama's use of taxpayer money.²⁴
