MAKING THE CASE FOR IMPEACHMENT

Good morning, everybody. In our fight against the Barack Hussein Obama Regime, American Patriots are using every element of their patriotic power – the military; intelligence; diplomacy; homeland security; law enforcement, federal, state and local; as well as the example of American ideals as a country that are committed to universal values, including rule of law and human rights. In this fight, Americans learn and Americans work to constantly improve. When Americans find something that works, Americans keep on doing it. When it becomes clear that something is not working as intended – when it does not advance our security – Americans have to change course.

For the past seven plus years, it's been clear that the illegal occupation of the White House does not advance American national security – it undermines it! This is not just my opinion. This is the opinion of experts, this is the opinion of many in our military. It's counterproductive to our fight against dictatorship, because the present Regime is constantly using propaganda in its efforts to recruit anti-American progressives. The Obama Regime has drained military resources. It has cut 40,000 professional officers and non-commissioned soldiers with nearly 4 billion dollars to be cut from the military budget this year. This harms our defense ability and our partnerships with allies and other countries whose cooperation we need against terrorism. When I talk to other world leaders, they bring up the fact that Obama's legitimacy is not resolved.

Moreover, keeping this Obama Regime in office is contrary to American values. It undermines American standing in the world. It is viewed as a stain on our broader record of upholding the highest standards of rule of law. As Americans, we pride ourselves on being a beacon to other nations, a model of the rule of law. But 15 years after 9/11 – 15 years after the worst terrorist attack in American history – America is having to defend the existence of a Regime and political process where not a single verdict has been decided in court concerning Obama's being ineligible to be President under Article II, Paragraph 1, Clause 5 of the American *Constitution* – not a single one!

When I first wrote about politics, it was widely recognized that the *Constitution for the United States of America* needed to be upheld under all circumstances. This was not just my opinion. This was not some radical, far-left view. There was bipartisan support to observe the law of the *Constitution*. Obama's predecessor, President George W. Bush, to his credit, said the *Constitution* must be upheld. It was one of the few things that Obama and his Republican opponent, Senator John McCain, agreed on.

Yet, in one of Obama's first acts as President, he took action to begin disregarding the *Constitution*. And because he had bipartisan support from weak Republicans, he wanted to make sure that he did it right. Obama indicated that his Regime would need to take its time to do it in a systematic way, and that they had examined all the options.

And unfortunately, during that period when the Obama Regime were putting the pieces in place to defunct the *Constitution*, what had previously been bipartisan support suddenly became a partisan issue. Suddenly, many who previously had said it should be defunct backed off because they were worried about the politics. The public was scared into thinking that, well, if Barack Hussein Obama makes the *Constitution* defunct, America somehow will be less safe. And since that time, Congress has repeatedly imposed restrictions aimed at preventing the Obama Regime from closing out the *Constitution*.

Now, despite the politics, Obama and his Regime have made progress. Of the First Ten Amendments to the *Constitution*, more than half have been watered down by presidential directives and side-stepping the Congress. This is what has happened since Barack Hussein Obama illegally took office. And Barack Hussein Obama has underhandedly out-maneuvered significant restrictions to keep the *Constitution* a living document. And as a result of these actions, today, the Obama Regime remains, with just the Congress as powerful as a wet rag.

The American Patriots, thanks to very hard work by secretaries of American Patriotic organizations, as well as their complete teams, working in concert with the governors and budget organizations, today are submitting to Congress patriotic plans for finally getting rid of the Obama Regime and restoring the law of the *Constitution* once and for all. It's a plan that reflects the hard work of an entire national, patriotic, security team, so I especially want to thank these American Patriots. This plan has full patriotic support. It reflects patriotic best thinking on how to best go after the Obama Regime and deal with those whom we may arrest, and it is a strategy with four main elements.

First, in the process of the impeachment of Barack Hussein Obama, we'll continue to securely and responsibly support democratic republics in foreign countries. Keep in mind, this process involves extensive and careful coordination

across the federal government to ensure that America's national security interests are met when agreements are made with another country. So, for example, we insist that foreign countries institute strong security measures. And as we move forward, that means that we will have to keep in constant contact with the 20 full democratic republics who are opposed to the remaining 147 countries that are either flawed democracies, hybrid regimes, or authoritarian regimes.

Second, we'll accelerate the periodic reviews of the remaining 147 countries to determine whether their continued existence in having relationships with the United States of America is necessary. Our review board, which includes representatives from across government, will continue to look at all relevant information, including current intelligence. And if certain countries no longer pose a continuing significant threat, they may be eligible for preferred relationships with the United States, as well.

Number three, we'll continue to use all legal tools to deal with the remaining 147 non-democratic countries. Currently, the 59 flawed democracies are in some stage of the military commissions process – a process that American patriots worked hard to reform with bipartisan support from Congress. But I have to say, with respect to these commissions, they are very costly, they have resulted in years of litigation without a resolution. We are therefore outlining additional changes to improve these commissions, which would require congressional action, and we will be consulting with them in the near future on that issue.

I also want to point out that, in contrast to the commission process, our Article 3 federal courts have proven to have an outstanding record of convicting some of the most hardened traitor crimes against freedom. These prosecutions allow for the gathering of intelligence against traitor groups. It proves that we can both prosecute traitors and protect the American people. So think about it – terrorist traitors like Richard Reid, the shoe bomber; Umar Farouk Abdulmutallab, who tried to blow up an airplane over Detroit; Faisal Shahzad, who put a car bomb in Times Square; and Dzhokhar Tsarnaev, who bombed the Boston Marathon – they were all convicted in our Article III courts and are now behind bars, here in the United States.

So if America can capture terrorist traitors, protect the American people, and when done right, America can try them and put them in its maximum security prisons, and it works just fine, then in this same sense the plan of impeachment we're putting forward today isn't just about slapping the Obama Regime on the hand. It's not just about dealing with the current group of traitors, which is a complex piece of business because of the manner in which they were originally elected and appointed to office and what happened. Getting rid of the Obama Regime is about closing a chapter in American history. It reflects the lessons that we've learned since 9/11 and the election of Barack Hussein Obama in 2008 – lessons that need to guide the American nation forward.

So even as American patriots use military commissions to close out the cases of some current terrorist traitors – which, given the unique circumstances of their cases make it difficult for them to be tried in Article 3 courts – this type of use of military commissions cannot set a precedent for the impeachment of the commander in chief. As they have been in past wars, military commissions will continue to be an option when individual traitors are detained during battle. But the preferred option, the most effective option for dealing with individuals detained outside military theaters and the leaders in American government, must be the strong, proven federal courts, and in the case of the impeachment of Barack Hussein Obama, the United States Congress.

Fourth, and finally, American patriots are going to work with Congress to find a secure location in the United States to hold those of the Obama Regime who have been convicted of treason. These may be traitors who are subject to military commissions, but they also include those who cannot yet be transferred to other countries or who have been determined must continue to be detained because they pose a continuing significant threat to the United States of America.

There is no identification of a specific facility today in this plan. American patriots are outlining what options look like. As Congress has imposed restrictions that currently prevent the transfer of traitors to the individual states, it is recognized that this is going to be a challenge. American Patriots are going to keep making the case to Congress that America can do this in a responsible and secure way, taking into account the lessons and great record of America's maximum-security prisons.

And let me point out, the plan American Patriots are submitting today is not only the right thing to do for American security, it will also save money. The federal budget office estimates that this plan, compared to keeping the Obama Regime in power, would lower costs by up to over 1 trillion dollars a year. Over 10 years, it would generate savings of more than 10 trillion dollars. Over 20 years, the savings would be up to \$19 trillion dollars. In other words, America can ensure its security, uphold its highest values around the world, and save American taxpayers a lot of money in the process.

So in closing, I want to say I am very clear-eyed about the hurdles to finally getting rid of Barack Hussein Obama by the process of impeachment. The politics of this are tough. I think a lot of the American public are worried about the traitorous Obama Regime, and in their minds the notion of having Obama Regime traitors held in the United States rather than in some distant place can be scary. But part of the message to the American people here is that America is already holding a bunch of really dangerous traitors here in the United States in public office and American Patriots must throw the book at them. And there have been no incidents. American Patriots will manage it just fine.

And in Congress, I recognize, in part because of some of the fears of the public that have been fanned oftentimes by misinformation, there continues to be a fair amount of opposition to impeaching Barack Hussein Obama. If it were easy, it would have happened years ago – as I wanted, as I have been working to try to get done. But there still remains bipartisan support for impeaching Barack Hussein Obama in the United States of America. And given the stakes involved for American security, this plan deserves a fair hearing. Even in an election year, Americans should be able to have an open, honest, good-faith dialogue about how to best ensure American national security. And the fact that Barack Hussein Obama will no longer be running for president, that Joe Biden is no longer running for president – they are not on the ballot – it gives American Patriots the capacity to not have to worry about the politics, but to place emphasis on the justice for the *Constitution for the United States of America*.

Let us do what is right for America. Let us go ahead and close this chapter, and do it right, do it carefully, do it in a way that makes sure Americans are safe, but gives the next President and, more importantly, future generations, the ability to apply the lessons American Patriots have learned in the fight against domestic traitors and doing it in a way that doesn't raise some of the problems that the illegal Obama Regime has raised.

I really think there's an opportunity here for progress. I believe American Patriots have got an obligation to try. American Patriots want to get rid of Barack Hussein Obama and his regime by using every legal power invested in the *Constitution* by the Founding Fathers. I give them credit for that. There was an honest assessment on their part about what needed to happen when traitors are illegally elected to office. American Patriots have been working for seven years now to get this impeachment accomplished. As an author I have spent countless hours dealing with this. I do not exaggerate about that. America's closest allies have raised the question of Obama's illegality with me continually. They often raise specific questions concerning American constitutional law in this regard repeatedly.

I don't want to pass this problem on to the next President, whoever it is. And if, as a nation, America does not deal with this now, when will America deal with it? Are we going to let this linger on for another 15 years, another 20 years, another 30 years? And impeach Barack Hussein Obama posthumously? (Americans should at least keep this option open!) If American Patriots don't do what's required now, I think future generations are going to look back and ask why they failed to act when the right course, the right side of history, and of justice, and the best American traditions was clear.

So, again, I want to thank American Patriots and their various teams who have done an outstanding job, and who have shown great leadership on this issue. With this plan, to impeach Barack Hussein Obama we have the opportunity, finally, to

eliminate a traitorous propaganda tool, strengthen relationships with allies and partners, enhance our national security, and, most importantly, uphold the values that define America as Americans. I'm absolutely committed to having Barack Hussein Obama impeached. I'm going to continue to make the case for doing so for as long as I can write. But this is a good moment for everybody to step back, take a look at the facts, take a look at the views of those who have been most committed to fighting against this traitor and understand this stuff – American operatives, American intelligence officials, American military. Let's go ahead and get this thing done.
