

THE INCREDULITY OF A BIDEN-HARRIS PRESIDENCY

PROEM

The guiding concept supporting this essay is **virtue**. Supplementing this term are the words *ethical* and *moral*. It is, therefore, necessary to comprehend the development and meaning of the words. We shall begin with a short etymological presentation concerning the nomenclatures.

ETYMOLOGICAL BACKGROUND

The word **virtue** has its Indo-Germanic word root stem in **uīro-s** meaning *the strong* from which the present-day word *man* stems. The word root stem also connotes the *right one*, and *hero*, as well as *strength* in various old languages as *a person who has moral excellence, moral strength*. There is a possible relationship to the word root stem **wie-⁵**, meaning *vital force*.

The word *virtue* appears in the English language sometime before 1200 in the phrase *by virtue of*, meaning *by the power of* or *efficacy of*. The Middle English spelling *virtu*, which was influenced by the Latin *virtūtem* originally appeared in Anglo-French and Old French as *vertu*. In approximately 1384, the word is used in Middle English to mean *superiority, unusual ability, efficacy, and having an inherently good quality*, as well as *goodness* and *righteousness*. The nomenclature appears passim in the related words *valor, valiant* in *Kyng Alisaunder*.¹ The meaning of *acting morally, being good, just, righteous, showing virtue*, appears in Middle English sometime before 1439.²

The term **ethical** and its related orthographical forms concern *a person's behavior from a philosophical standpoint with emphasis on idealistically viewed standards of right or wrong*. The Indo-germanic word root stem is **seu-**², meaning *one's own*, which appears in Greek as *ēthos*, meaning *custom, disposition, or trait* (of a person). The word *ethics* appears in the *Prologue to The Legend of Good Women* (14th century) by Geoffrey Chaucer (1342/1343-1400) in about 1386.³ The adjective form *ethical* appears in English in approximately 1607.⁴

The term **moral** and its related orthographical forms pertain to *a personal behavior measured by the prevailing standards of integrity*. The Indo-Germanic word root stem is **mē-**¹, which means *to be of hefty and strong will*. Thus the word expresses *certain qualities that an individual has in one's mind*. The word *moral* appears in *The Psalter, or Psalms of David* (exact date unknown) by Richard Rolle (1290/1310-1349), and was adapted from the Old French *moral* which derived from the Latin *mōrālis*, *having to do with morals and manners*. The term *moral* is cognate with the Old English *mōd*, meaning *spirit, or courage*.⁵

A person who has virtues conforms and conducts one's life by following ethical and moral principles.

THE PRESENTATION

The United States of America was built on virtue, and the country needs virtue to succeed. The nation is on the cusp of another significant moment in history as it prepares for its Presidential Election amid the COVID-19 pandemic.⁶ The circumstances around this election year make it especially meaningful and intriguing, considering the scandal of Russia-Gate and the Democrat-Party-fabricated impeachment process against President Trump, the Democrat Party drama-filled tenure of President Donald Trump that has

continuously been criticized with false allegations coming from the Democrats, and the limited number of viable Presidential candidates among the Democrats. The current running mates on the Democrat Party ticket are Joe Biden and Kamala Harris. However, these two candidates are not suited for the highest office of the United States of America.

A Biden-Harris presidency would be incredulous because of at least ten reasons:

- 1) their lack of ethics and morality
- 2) their penchant for corruption
- 3) their desire for self-preservation
- 4) their belief in utopianism
- 5) their positions against the principles of the Founding Fathers
- 6) their blaming others and avoidance of accountability
- 7) their lack of self-awareness
- 8) their lack of foresight
- 9) their negative political rhetoric
- 10) their intellectual deficiency and legal ineligibility

ETHICS AND MORALITY

An individual's immorality is usually a precursor of corrupt behavior. Joe Biden holds that he met his wife Jill after her separation from her husband, Bill Stevenson. However, Mr. Stevenson reveals that an affair between Joe and his then-wife Jill was the cause of their divorce.⁷ Sources claim that they had illicit rendezvous even though Stevenson was a close friend of the Bidens and played a significant financial contribution that aided the beginning of his political career in the 1970s.⁸ These facts highlight the morality or the lack thereof, of Joe Biden as a person. He had no remorse in having an affair with a close friend's wife and even proceeded to cause the Stevensons to divorce so that he could marry Jill. While one may argue that Joe Biden is human and to be human is to err, the argument would fail to recognize the value and significance of leadership. Leaders are

called to a higher standard. They should epitomize the best of character and behavior in society.

Kamala Harris offers little prospect as an ethical and moral leader, as evidenced in her beliefs and policy proposals. She has openly supported the application of affirmative action on the provision of life-saving medical treatment. She proposes the use of race as a foundation for making decisions on the distribution of life-saving resources.⁹ She does not propose the use of validly researched data to ensure the economically and environmentally hardest-hit areas are allocated the most resources. She recommends a radical policy change that would substantially deprive people of life-saving medical treatment because of the prioritization of remedying the racial inequalities that she claims have long plagued the United States of America. Her proposal is not only unconstitutional, but it is also immoral and unethical. It fails to embody the vision and mission of the United States, especially during the COVID-19 pandemic.

Another significant castigation on Harris's character and judgment is based on her poor record as the District Attorney of San Francisco. Kamala Harris morally failed the San Francisco judicial system by not enforcing a policy designed to ensure that all prosecutors reveal all evidence that may be favorable to a defendant.¹⁰ She intentionally neglected to implement the Brady Policy, known as Brady Disclosure Requirements,¹¹ despite recommendations from her assistant district attorneys. They noted that many cavalier prosecutors failed to disclose evidence that was vital in assisting the defendant in proving one's innocence. As a result, numerous criminal charges and cases were dropped, which led to thousands of criminals walking free, and in worse cases, innocent people were sent to prison. Her failure not only highlights her inability to uphold ethical conduct in executing her duties but also her moral failure to protect the rights of every individual, especially those who are accused. One could question her judgment based

on her moral shortcomings, which present a much larger argument when considering the Presidency of the United States of America is eventually is at stake.

Not only has her poor judgment affected the legal system but also the fabric of society and community by passing laws that essentially imprison parents for their children's failures. As San Francisco District Attorney, she first proposed a local truancy law that would imprison or fine parents whose children were truant. The children did not attend school regularly as required. She then sponsored the law at the state level and got it passed in 2010. Parents with children who were considered chronic truants could face up to \$2,000 in fines and a one-year jail term.¹² This law resulted in many parents receiving jail terms, some up to 6 months. This law criminalized parents for their children's truancy, which raises significant questions about her beliefs, ethics, and morality. Of course, parents must be held responsible for their children's illegal behavior. However, the children must also be held accountable.

Kamala Harris is also responsible for ordering a police raid on the home of David Daleidan of the Center for Medical Progress for "exposing the crimes of her church and their priests, for exposing Planned Parenthood, "the baby murdering hitmen, and their proselytizers for selling murdered baby body parts" for financial gain.¹³ Many of Kamala Harris's political patrons are linked to Planned Parenthood. This relationship with Planned Parenthood obviously raises important questions about her ethics and morality as a leader.

Ethical leadership decreases the propensity of subordinates to disengage morally.¹⁴ Joe Biden has consistently failed to prove himself a pillar of morality in society, and a Biden-Harris presidency victory could lead not only the Democrats and the Democrat

Party but also the entire nation to disengage from necessary moral values. Thus a repeat of the Obama presidential regime that was infested with political scandals would take place. This is especially significant when considering ethical leaders have the most massive positive influence on people with weak moral identities.¹⁵ Unethical and immoral leaders could have the largest negative influence on the American citizenry according to this standpoint: *If Biden and Harris can conduct their lives unethically and immorally and not be held responsible for their actions, then why can't the citizens do the same?*

CORRUPTION

Corruption is arguably one of the most significant social plagues to affect human society from time immemorial. Corruption entails fraudulent and dishonest conduct by an individual in power to manipulate the outcomes of a process to their favor. While Biden represents a political party that was initially founded on the goal of freedoms for all, he portrays behavior that is associated with corruption. In a yet-to-be published book, Bill Stevenson claims that Frank Biden, Joes Biden's brother, took \$3,000 from Stevenson to given to the teamsters' union to ensure that the *Wilmington News Journal*, which endorsed Biden's competitor, Caleb Boggs, would be released three days after the polls closed. Not only does this incident depict his corrupt nature, but it also shows his drive to ensure self-preservation. Biden's involvement in the Ukraine-Burisma financial scandal¹⁶ underscores his penchant for financial corruption and self-preservation. The same can be said of Kamala Harris's willingness to receive her political positions and financial gains by opening her legs and going to bed with Willie Brown, the former Mayor of San Francisco during the time of their long sleeping with each other¹⁷ and, as the *Urban*

Dictionary describes, it does not rule out that she likely *slobbered his nob like the corn on the cob*¹⁸ in order to be appointed to a higher position on the political ladder.

SELF-PRESERVATION

While Joe Biden and Kamala Harris represent the Democrat Party, they pursue their interests and are focused on achieving self-preservation within the Democrat Party as well as within the American political arena. In his quest for the presidency, Joe Biden sought a female running mate to ensure a more inclusive government and win female voters for the Democrat Party. However, his preferred choice of a running mate was not Kamala Harris, but Gretchen Whitmer, the present governor of Michigan who is undergoing a voter recall to relieve her of the governorship.¹⁹ The Democrat Party was thrown into panic and strong-armed Biden into picking Kamala Harris because they think she offers more diversity through racial inclusion as an African (?) American female candidate. Part of the influence within the Democrats can be traced back to pressure from Black women activists.²⁰ As such, while Biden may portray the image of an individual led by virtue, he is guided by the innate drive to ensure self-preservation of his political legitimacy. His political partnership with Harris is based on the need to secure votes in swing states and his inability to stand up to pressure from interest groups as opposed to providing the American people with principle-based leadership.

Another reason for Biden selecting Harris as a running mate is her contribution to his presidential campaign. In June 2020, Senator Harris's virtual fundraiser raked in \$3.5 million in donations for Joe Biden's presidential campaign, outdoing all other Democrats

except former President Barrack Obama, who raised over \$6 million.²¹ Despite Susan Rice initially being the favorite African-American female candidate for the Democratic Party vice-presidential nomination, she could only manage \$24,000 in her fundraiser. For her ability to command financial resources, Kamala Harris secured her position as the running mate for Biden's presidential bid.²² There has been little protest among Black Female activists over the fact that other women within the Democratic Party, such as Susan Rice, Stacey Abrams, or Karen Bass, may offer better candidates compared to Kamala Harris because of the financial backing she commands. "George Soros owns her."²³ As such, Kamala Harris and Joe Biden are inherently guided by a need to ensure their political self-preservation.

Kamala Harris has consistently shown that she is not an issue-driven politician but one who is motivated by the prospect of power and the limelight that comes with it. In previous debates, she has approached questions in a cagey fashion to mitigate any negative impact on the polls. This can be attributed to the fact that she has little knowledge and dedication to policies that other candidates possessed in the primaries. Her political career has been one of privilege. She has quickly risen through the ranks in her political career by striking deals with potential competitors and the Democrat Party, virtually clearing the path for her political success. She has not had to fight for her position and has largely been privileged by the support of former mayor-lover Willie Brown.²⁴ The allegations of the significant influence of Brown over her political career in

its infancy have never been disproven, and she has sought to distance herself from Brown to protect her image and suitability as a political candidate. Her first appointments to political positions between 1994 and 1995 took place during the time of their relationship. The growth and progress recorded in her political career can be traced to the two initial political appointments by Brown, which highlight the fact that she has not had to fight to get her political appointments. She is inherently motivated to preserve her career and advancement towards the highest political office in the land.

While one may perceive self-preservation as an important quality for a leader because it is regarded as the basic instinct in human beings that drives them to protect themselves from harm or death, it is detrimental to leadership. Self-preservation can be a stumbling block in leadership. According to renowned American author and speaker on leadership. John C. Maxwell, self-preservation runs contrary to the nature of leadership, which entails being of service to others.²⁵ A self-preserving mentality causes a leader to exploit their subordinates as opposed to equip and inspire them to achieve greater milestones.²⁶ This is evidenced in Biden's use of proxies, such as his brother Frank and possibly his son Hunter Biden in the Burisma scandal to conduct his dirty business of bribery to achieve his political goals. In the process, leaders who are inherently self-preserving provoke resentment, command little respect, and achieve little within the scope of their field.²⁷

This condition self-preservation is evidenced by Biden selecting Harris as his running mate. The situation has not received significant or unanimous support from party followers. Not all Democrats are convinced of Harris's suitability because she has very little in common with the American Black experience.²⁸ As a first-generation immigrant

who grew up in liberal enclaves, she lacks the experiences that have defined the struggle of Black Americans in society that has been historically plagued with racism. As such, she commands little respect from fellow African-Americans, especially those in the Democrat Party. Throughout his book, Maxwell argues that self-preserving leadership is an attribute concerning three main issues: 1) the fear of change, 2) the stoppage of career and political growth, and 3) the loss of self-belief.

UTOPIANISM

The philosophy employed by a leader significantly influences the decisions that the leader makes and the beliefs that guide the process of decision-making. Biden and Harris depict elements of utopianism in their arguments as they portray a vision that is mainly idealistic and fails to consider reality. A salient example is Kamala Harris's endorsement of voting rights for 16-year-olds in April 2019.²⁹ While this idea has been pursued by liberals in the past, it is mainly flawed as research consistently shows that few 16-year-olds depict the requisite levels of maturity to objectively make significant life-changing decisions such as electing the next President. While 16-year-olds may occasionally reach the cognitive capacities of an adult, they can only successfully achieve this level in psychosocial maturity from 18 years onwards.³⁰ However, in 2015, Kamala Harris admitted the fact individuals between the ages of 18 to 24 are inherently stupid.

Kamala Harris has a positive view of Marxism/Socialism/Communism.³¹ Biden is not a Marxist-Socialist-Communist politician. But he has been supportive of Communist

China and even Cuba.³² Biden is a *yes man* and he would conduct himself accordingly and do their bidding should he be elected President. Kamala Harris would assuredly advise him on the superiorities of Marxism/Socialism/Communism.

ANTI-FOUNDING FATHER PRINCIPLES

While Joe Biden and Kamala Harris represent the Democratic Party, which is supposed to embody the concept of freedoms for everyone, they do not necessarily subscribe to these beliefs. Biden and Harris have repeatedly shown an inclination towards anti-Founding Father principles in their positions as Democrat Party politicians and in the United States Senate. In her campaign, she has reportedly held that she would require a comprehensive gun safety legislation within the first 100 days of being elected to the office of the presidency (and the vice-presidency).³³ She advocates the aggressive use of universal background checks, a ban on assault weapons, and the repeal of the immunity provided to corporate gun manufacturers and dealers. However, her opinions on gun control are contrary to the *Constitution for the United States of America* as envisioned by the Founding Fathers when they drafted the First Amendment to the *Constitution*. Harris is seen as a threat to the First Amendment because of her stance on gun ownership amid growing tension and hostility towards the police throughout the United States.

UNACCOUNTABILITY

Accountability is arguably one of the critical characters that leaders require to be diligent in their work and evoke the loyalty and support of their subordinates. However, Biden and Harris have depicted little to no accountability for their decisions and actions. Biden appears to be accountable to the banks that have consistently provided him with financial support, which is much greater than the support provided to the incumbent President Donald Trump. Biden's choice of Harris also served to quell fears in Wall

Street about the potential policy effects the vice-presidential running mate would have on their business. Biden's choice did not reflect the will and desires of the electorate as Harris dropped out of the Democrat Party primaries before the first vote was cast.³⁴ Despite significant media backing, she failed to garner enough support to get to the ballot.

The lack of accountability depicted by Biden and Harris could have significant ramifications for the United States amid the COVID-19 pandemic. There is a considerable risk of electing a presidency that does not care about its people and their problems.

LACK OF SELF-AWARENESS

Joe Biden and Kamala Harris depict a significant lack of self-awareness in their actions and words, especially during political debates. Neither one is an American patriot! Biden has been identified as one who has problems with unmanageability, which stems from his laziness and his reluctance to delegate³⁵ As such, Biden is renowned for not getting the most significant and important things done because he will not do them. Joe Biden is lazy, and he will not let others undertake accomplishments because he will not delegate. This lack of self-awareness affects his perception of the truth as he claims to have done things that he has not done and denies doing something that he has, but takes credit for the success of others.³⁶ This is evidenced by the fact that he is on record boasting of academic achievements he does not have.³⁷ Biden is insecure about himself, especially his intelligence, and once even snapped back at a voter by holding that he had a higher IQ than the voter or any voter.³⁸ Whether or not he knows what an IQ is remains to be seen! Considering the threat of the COVID-19 pandemic and the ever-evolving

global threat of terrorism, a Biden-Harris presidency would pose significant problems for the American people. The most important things will not get done, which may further threaten the social and economic stability of the United States. This might be their goal. INTELLECTUAL DEFICIENCY AND LEGAL INELIGIBILITY

Joe Biden's intellectual capacities are suggestive that he was a graduate of a common core high school before Common Core education was ever developed.⁴⁰ While most of the arguments presented herewith have focused on the characters and personalities of Joe Biden and Kamala Harris, there is a significant point that cannot be ignored: the proverbial elephant in the room, the ineligibility of both as presidential candidates. While one may argue that Biden may deliver the requisite performance as commander-in-chief with the right support, Kamala Harris's case presents a more significant challenge. The eligibility of Kamala Harris's nomination, as was the case for former President Barack Obama, who was an illegal President, – The Democrat Party has no qualms doing politics illegally – is questioned based on her status as a citizen, which is covered in Article II of the *Constitution for the United States of America* and by the 12th Amendment. Article II explicitly says that "no person except a natural born citizen ... shall be eligible to the office of President," and the 12th Amendment asserts that "no person constitutionally ineligible to the office of President shall be eligible to that of Vice-President of the United States." Kamala Harris's father is Jamaican and her mother is a naturalized United States citizen from India. However, at the time of her birth in 1964, neither of her parents were naturalized citizens of the United States.⁴² Based on the legal definitions provided in the *Constitution* and accepted by international law, Kamala Harris is not a natural-born citizen of the United States and is not eligible for the office of the President or Vice President. While her supporters cite the fact that she was born in Oakland,

California as proof of her status as a natural-born citizen, the location of birth does not determine one's status as a natural-born citizen.⁴³ Even though the 14th Amendment does provide that "all persons born ... in the United States, and subject to the jurisdiction thereof, are citizens", there is a need to assess the second phrase to understand the intended meaning of this law. the phrase "subject to the jurisdiction of the United States" refers to the full or complete jurisdiction of the United States and not the partial jurisdiction as is the case with temporary sojourners.⁴⁴ As per the intended meaning of the *Constitution*, the status of the parents at the time of a child's birth is vital to determining their eligibility as a citizen and especially eligibility as a natural-born citizen.

Additionally, the Founding Fathers of the United States of America relied on the *Law of Nations*, an internationally accepted legal codification by Emmerich de Vattel (1714-1767) when developing the United States *Declaration of Independence* and the *Constitution for the United States of America*.⁴⁵ As per the *Law of Nations*, a natural-born citizen is one who is born to parents who are citizens.⁴⁶ As such, based on the fundamental international legal definition and documentation used to develop the *Constitution* and embody its essence, Kamala Harris is not a natural-born citizen. Instead, she is considered an anchor baby, i.e., a child born to non-citizen parents in a country that allows birthright citizenship.⁴⁷ However, it is essential to note that the accurate interpretation of the law does not provide birthright citizenship. Instead, it is an intentional misinterpretation that has plagued the legal system for the past fifteen years.

This argument not only questions Harris's eligibility as a Vice President but also as a Senator. Given that Harris's parents were not naturalized by before Kamala's 16th birthday, she would have to become naturalized. To date, there are no records of her naturalization. As such, her eligibility as a candidate and as a Senator is in significant doubt and borders on being 100 percent illegality.

Not only is Kamala Harris's legitimacy as a candidate in question but also her legitimacy as an African-American or a candidate that represents the African-American is highly questionable. There is little to no evidence to show that Kamala Harris has had an authentic African-American experience.⁴⁸ Not only were her parent immigrants in the United States, but she also spent part of her childhood in Canada.⁴⁹ Neither were her family heritage nor her childhood experiences linked to the African-American history of struggle, pain, and hardship in a nation that has a partial racist history. This lack of connection to the rich history of African-American people in the United States raises significant questions as to her comprehension of the issues that affect African-Americans since the emancipation of slaves by President Abraham Lincoln.⁵⁰ Kamala Harris's lineage deprives her of the capacity to comprehend the issues that affect African-Americans because she was born to two affluent immigrants and lived a life of privilege.

CLOSURE

A Biden-Harris presidency would pose significant problems for the United States of America amid the COVID-19 pandemic. One would fail to recognize the value and significance of leadership. Leaders are called to a higher standard as they should epitomize the best of character and behavior in society. Kamala Harris offers little prospect as an ethical and moral leader, as evidenced in her beliefs and policy proposals.

She has openly supported the application of affirmative action on the provision of life-saving medical treatment. Her plan is not only unconstitutional, but it is also immoral and unethical. It fails to embody the vision and mission of the United States, especially during the COVID-19 pandemic. Kamala Harris morally failed in the San Francisco judicial system.
