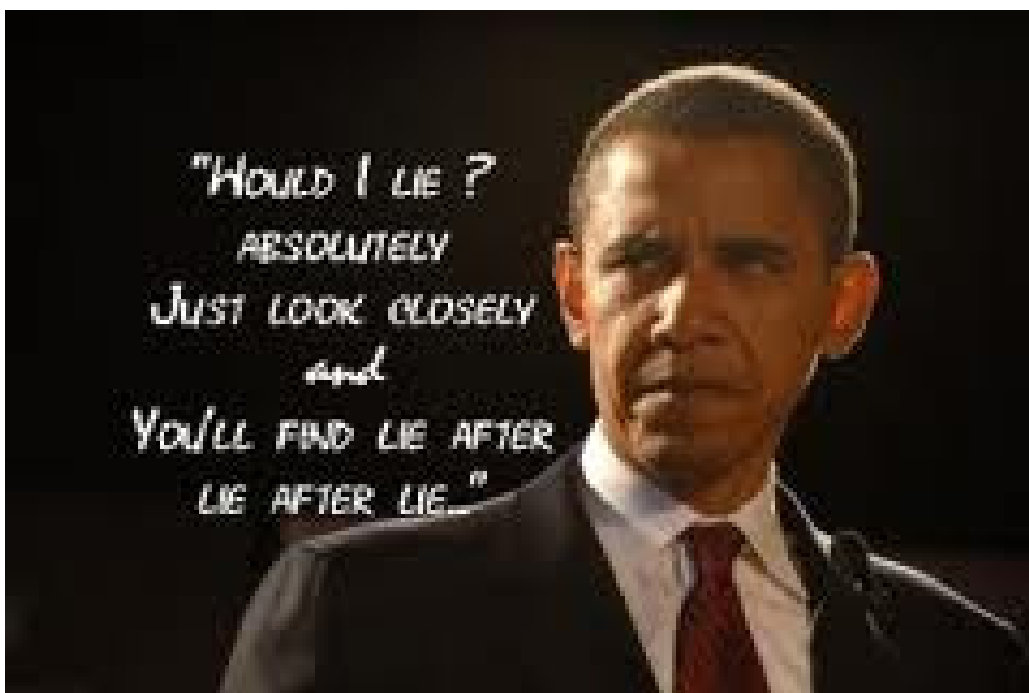

1. THE (putative) PRESIDENT: Good evening. (Is this a pp (putative president) threat?) Tonight, I want to talk about the debate we've been having in Washington over the national debt LIE 1 -- a debate that directly affects the lives of all Americans. LIE 2

has always said NO to any Republican proposal to attack the problem of the national debt. Yet, while saying NO, Barack Hussein Obama has played a lot of golf.

LIE 2 is a lie because although the national debt affects the lives of all Americans, Barack Hussein Obama is not telling the complete truth. The national debt also affects the financing of projects not concerned with the United States of America, like the renovation and rehabilitation of mosques program throughout the world, although "... the Code of Federal Regulations, 'USAID (United States Agency for International Development) funds may not be used for the acquisition, construction, or rehabilitation of structures to the extent that those structures are used for inherently religious activities' "<sup>4</sup>

2. For the last decade, we've spent more money than we take in. LIE 3 In the year 2000, the government had a budget surplus. LIE 4 But instead of using it to pay off our debt, the money was spent on trillions of dollars in new tax cuts, LIE 5 while two wars and an expensive prescription drug program were simply added to our nation's credit card. LIE 6

CLARIFICATION/COMMENT: LIE 3 is a lie because throughout the last **five decades** the federal government has spent more money than it receives in taxes. The reader should note that during these **five decades** the Democratic Party has had five presidents occupying the White House. The Republican Party has also had five presidents occupying the White House. Every Republican President attempted to curb government spending and to invigorate the economy with tax cuts so that businesses would have more money to invest and undertake the hiring of more employees. The Democrat presidents went on spending sprees. The statement is also a deviation to direct the nation's attention to Barack Hussein Obama's predecessor President George W. Bush and accuse him of being responsible for the government's deficit problem.

LIE 4 is a lie because "The government can have a surplus even if it has trillions in debt, but it cannot have a surplus if that debt is **increased** every year."<sup>5</sup> President Clinton's "claimed \$236 billion surplus resulted in the national debt increasing by \$18 billion."<sup>6</sup>

LIE 5 is a lie because the tax cuts under President George W. Bush enabled the unlocked money as a result of the tax cuts to be invested in the economy. Therefore, it is wrong to say that "money was spent on trillions of dollars in tax cuts" because these trillions of dollars were invested in the national economy and were not tax cuts for the rich, which is what Barack Hussein Obama is insinuating. This is not to say that the rich do not reap some rewards in tax cuts. They did and they do. At the same time it must be said that the rich are the ones who really pay taxes,<sup>7</sup> except for Senator John Kerry (D-MA) who owes Massachusetts more than \$500,000 in taxes<sup>8</sup> and aides to Barack Hussein Obama who owe \$800,000 in back taxes,<sup>9</sup> as well as federal employees who owe(d) more than \$1,000,000,000, in back taxes.<sup>10</sup>

LIE 6 is a lie because the plan that Barack Hussein Obama is referring to is Medicare Part D. The result of the latest research indicates that the plan reduces health spending.<sup>11</sup>

3. As a result, the deficit was on track to top \$1 trillion the year I took office. **LIE 7** To make matters worse, the recession meant that there was less money coming in, and it required us to spend even more -- on tax cuts for middle-class families to spur the economy; on unemployment insurance; on aid to states so we could prevent more

teachers and firefighters and police officers from being laid off. LIE 8 These emergency steps also added to the deficit. LIE 9

CLARIFICATION/COMMENT: LIE 7 is a lie because the federal deficit in 2008 was \$459 billion. When Barack Hussein Obama took his illegal position on January 20, 2009, the federal deficit was already over 1.4 trillion dollars.<sup>12</sup> A reason for this large increase from 2008 is due to The Asset Relief Program (TARP)<sup>13</sup> and Barack Hussein Obama added another \$3.3 trillion in 20 months.<sup>14</sup>

LIE 8 is a lie because Barack Hussein Obama's \$2 trillion bailout for "tax cuts for the middle class to spur the economy, on unemployment insurance; on aid to states so that we could prevent more teachers and firefighters and police officers from being laid off" was a disguised pay-off to his union, big business, and campaign supporters.<sup>15</sup> Teachers and firefighters and policemen were never threatened with being laid off. Indeed, many received a salary raise as a result of the stimulus. Barack Hussein Obama's stimulus was for shovel-ready jobs that were never present.<sup>16</sup>

LIE 9 is a lie because the steps were not really emergency steps, unless one believes like progressives, leftists, obots, socialists, communists, and unionists. It would have been better for the market system to solve the problems of the economy. The market system always weeds out the failures. Government spending keeps failures alive.

4. Now, every family knows that a little credit card debt is manageable. But if we stay on the current path, our growing debt could cost us jobs and do serious damage to the economy. More of our tax dollars will go toward paying off the interest on our loans.

Businesses will be less likely to open up shop and hire workers in a country that can't balance its books. Interest rates could climb for everyone who borrows money — the homeowner with a mortgage, the student with a college loan, the corner store that wants to expand. And we won't have enough money to make job-creating investments in things like education and infrastructure, or pay for vital programs like Medicare and Medicaid. LIE 10

CLARIFICATION/COMMENT: LIE 10 is a lie because Barack Hussein Obama is stating possibilities that could happen to the economic situation in the United States of America as Democrats envision the happenings. These statements are really the statements of the Republicans and Barack Hussein Obama always discredits the Republicans because in his warped mind they cannot control the economy and are always supporting the rich. Yet Barack Hussein Obama uses the Republican Party's logic to argue for a deficit ceiling increase of \$2.4 trillion and an increase of taxes, when the problem is not a question of increasing taxes, but the uncontrolled spending by the federal government. In fact, the cutting of needless, federally funded programs like National Public Radio, and a decrease in taxes will cause an eventual economic upturn. There are presently 1607 federally-funded programs, half of which could be easily terminated.<sup>17</sup> Furthermore, why should the American government give millions of dollars to Palestinian organizations in order that they can then use the money to buy weapons to use in attacking Israel? Why should the federal government give \$2 billion dollars to Brazil to assist Brazilian petroleum (PETROBRAS) in drilling for oil off its coast?<sup>18</sup> Why is it necessary for the National Institute of Health to conduct a study to find out if a homosexual's penis size has a correlation to his sexual health? The research that began in 2006 has received \$889,769.<sup>19</sup> The putative president Barack Hussein Obama and the illegal vice president Joe Biden, as well as all of the regime's czars and cabinet members supporting the Barack Hussein Obama regime's crimes on the American people could make symbolical deficit reductions by having their salaries cut to zero dollars. they should be willing to do their anti-patriotic jobs for nothing. This would be the first place to start cutting back on waste.

5. Because neither party is blameless for the decisions that led to this problem, both parties have a responsibility to solve it. And over the last several months, that's what we've been trying to do. **LIE 11** I won't bore you with the details of every plan or proposal, but basically, the debate has centered around two different approaches.

**CLARIFICATION/COMMENT:** LIE 11 is a lie because over "the last several months" Barack Hussein Obama has not done anything to solve the deficit problem. Indeed, during the time the Democrats held a majority in both houses of Congress, they were neglect in solving the deficit limit problem.

6. The first approach says, let's live within our means by making serious, historic cuts in government spending. Let's cut domestic spending to the lowest level it's been since Dwight Eisenhower was President. **LIE 12** Let's cut defense spending at the Pentagon by hundreds of billions of dollars. Let's cut out waste and fraud in health care programs like Medicare -- and at the same time, let's make modest adjustments so that Medicare is still there for future generations. **LIE 13** Finally, let's ask the wealthiest Americans and biggest corporations to give up some of their breaks in the tax code and special deductions. **LIE 14**

**CLARIFICATION/COMMENT:** LIE 12 is a lie because Barack Hussein Obama has never proposed a deficit-cut plan that would return to the spending levels of the President Eisenhower years. Neither has any Democratic Party member of the Senate proposed such a plan. No American newspaper has printed articles concerning such proposals and there are no Google hits concerning such a plan.

LIE 13 is a lie because Barack Hussein Obama says it is necessary to stop waste and fraud in healthcare, yet Barack Hussein Obama did not consider this important in his first two-and-a-half years in office. The Barack Hussein Obama regime did nothing to combat waste and fraud in health care, but he wants to make health care in the United States of America available to illegal immigrants. On the contrary Barack Hussein



Obama is legalizing the fraud by proposing that illegal aliens should receive the health care that American tax payers receive.<sup>20</sup>

LIE 14 is a lie because there are no United States tax regulations that stipulate that large corporations and wealthy American should receive better and wider-coverage deduction possibilities than the small business or the American middle class. This author could not find any regulations that favor the wealthy and corporations over middle-class Americans and American small businesses.

7. This balanced approach asks everyone to give a little without requiring anyone to sacrifice too much. It would reduce the deficit by around \$4 trillion and put us on a path to pay down our debt. And the cuts wouldn't happen so abruptly that they'd be a drag on our economy, or prevent us from helping small businesses and middle-class families get back on their feet right now. LIE 15

CLARIFICATION/COMMENT: LIE 15 is a lie because Barack Hussein Obama's balanced approach is not a balanced approach. It means only *Let me spend more and you pay more!*<sup>21</sup>

8. This approach is also bipartisan. LIE 16 While many in my own party aren't happy with the painful cuts it makes, enough will be willing to accept them if the burden is fairly shared. While Republicans might like to see deeper cuts and no revenue at all, there are many in the Senate who have said, "Yes, I'm willing to put politics aside and consider this approach because I care about solving the problem. " LIE 17 And to his credit, this is the kind of approach the Republican Speaker of the House, John Boehner, was working on with me over the last several weeks. LIE 18

CLARIFICATION/COMMENT: LIE 16 is a lie because the approach is not bipartisan. It is not what the Republicans suggest, except maybe for the Republicans in Name Only (RINOs).

LIE 17 is a lie because Senate Democrats who have said, "Yes, I'm willing to put politics aside and consider this approach because I care about solving the problem." have said this because they are worried about being reelected to their positions in 2012 and they can campaign on a platform of saying they solved the deficit problem.

LIE 18 is a lie because Barack Hussein Obama did not work with Speaker John Boehner. Barack Hussein Obama did nothing.<sup>22</sup>

9. The only reason this balanced approach isn't on its way to becoming law right now is because a significant number of Republicans in Congress are insisting on a different approach -- a cuts-only approach — an approach that doesn't ask the wealthiest Americans or biggest corporations to contribute anything at all. And because nothing is asked of those at the top of the income scale, such an approach would close the deficit only with more severe cuts to programs we all care about — cuts that place a greater burden on working families. LIE 19

CLARIFICATION/COMMENT: LIE 19 is a lie because Barack Hussein Obama is not using facts. Barack Hussein Obama is using the tactics of class warfare. Barack Hussein Obama refuses to accept the economic fact that the less tax corporations and small businesses have to pay, the more secure are American jobs and hiring. The largest burden an American family has is to lose a job, which is most often the result of an increase in taxes.

10. So the debate right now isn't about whether we need to make tough choices. Democrats and Republicans agree on the amount of deficit reduction we need. LIE 20 The debate is about how it should be done. Most Americans, regardless of political

party, don't understand how we can ask a senior citizen to pay more for her Medicare before we ask a corporate jet owner or the oil companies to give up tax breaks that other companies don't get. **LIE 21** How can we ask a student to pay more for college before we ask hedge fund managers to stop paying taxes at a lower rate than their secretaries? **LIE 22** How can we slash funding for education and clean energy before we ask people like me to give up tax breaks we don't need and didn't ask for? **LIE 23**

**CLARIFICATION/COMMENT:** LIE 20 is a lie because Republicans and Democrats definitely do not agree on the amount of debt reduction in the budget. The Republicans in the House of Representatives and in the Senate, as well as the majority of citizens of the United States of America want exceedingly more cuts than do the Democrats.<sup>23</sup>

LIE 21 is a lie because regardless of the size of a company they are allowed certain tax deductions for business expenses. Furthermore, the subsidies of companies paid for by the tax payer are at a much lower niveau than the amounts of government money Barack Hussein Obama has *given away* to the so-called *green companies*. "...Obama's rich green friends get a \$7,500 tax break to subsidize expensive electric-car purchases like the \$41,000 Chevy Volt. Millionaire Elon Musk has pulled down \$465 million in federal Energy Department loans to build his luxury electric cars. Millionaire Henrik Fisker got \$520 million to build his own battery-powered golden chariots. Fortune 500 corporations GM, Chrysler, and Ford have received \$600 million in federal green loans combined. Millions in stimulus dollars have gone to giant corporations like A123 Systems (\$250 million), Dow (\$160 million), and South Korea's LGChem (\$150 million)."<sup>24</sup>

LIE 22 is a lie because rich hedge fund managers are in the 35 percent income tax category. Secretaries who have a yearly income of under \$34,500 are in the 15 percent category. The people who are in the 10 percent and 15 percent income tax category pay zero income tax on their dividends and their long-term capital earnings. Barack Hussein Obama strongly demands that the George W. Bush tax rates should expire by 2013. This means that the people who are in the 10 percent and 15 percent income tax

category will have to pay taxes on their capital gains and dividends. Barack Hussein Obama is lying about his protection of secretaries!

LIE 23 is a lie because Americans who are in an income category like Barack Hussein Obama and are paying the top 35 percent for the last ten years are not receiving an income tax break. Barack Hussein Obama does not understand what the meaning of an *income tax break* is. Barack Hussein Obama's idiotic logic is that if one's taxes are not raised, then the person is receiving an income tax break. We can surely call this rationale the idiotic progressive, leftist, obotic, socialistic, communistic, unionist thinking.

11. That's not right. It's not fair. LIE 24 We all want a government that lives within its means, but there are still things we need to pay for as a country -- things like new roads and bridges; weather satellites and food inspection; services to veterans and medical research. LIE 25

CLARIFICATION/COMMENT: These are pure scare tactics coupled with what is known in rhetoric as the *false choice technique*. The debater/speaker offers to the public his purported reasonable positions on an issue and then presents an exceedingly remote or abnormal example as that which the opposition wants, which is never the case, otherwise it would not be a *false choice*.

LIE 24 is a lie because the situation has nothing to do with fairness due to the fact that the idiotic ranting in paragraph ten is not the truth. There is no logic in saying that the content of the lies Barack Hussein Obama is telling the American public to accept as truths are unfair and not right because Barack Hussein Obama said they are the truth.

LIE 25 is a lie because the "things like new roads and bridges; weather satellites and food inspection; services to veterans and medical research" are not being questioned by the Republicans or the American people. There have never been demands from Republicans or the American people to stop the building of bridges, to stop food inspection, to stop weather satellites, to stop medical research. If one googles the material, there will be no hits.

12. And keep in mind that under a balanced approach, the 98 percent of Americans who make under \$250,000 would see no tax increases at all. None. **LIE 26** In fact, I want to extend the payroll tax cut for working families. **LIE 27** What we're talking about under a balanced approach is asking Americans whose incomes have gone up the most over the last decade -- millionaires and billionaires -- to share in the sacrifice everyone else has to make. **LIE 28** And I think these patriotic Americans are willing to pitch in. In fact, over the last few decades, they've pitched in every time we passed a bipartisan deal to reduce the deficit. The first time a deal was passed, a predecessor of mine made the case for a balanced approach by saying this:

**CLARIFICATION/COMMENT:** **LIE 26** is a lie because Medicare payroll tax on "households with incomes exceeding \$200,000 for singles and \$250,000 for married couples filing jointly will increase."<sup>25</sup>

**LIE 27** is a lie because Barack Hussein Obama's "budget does not extend the payroll tax cut."<sup>26</sup> Moreover, the tax cuts will expire in 2013. "The Bush tax cuts don't just offer tax relief to the wealthiest Americans. They offer it to just about anyone who pays federal income taxes. The scheduled expiration (at the end of) next year will result in the raising of the tax bill to every American taxpayer."<sup>27</sup>

**LIE 28** is a lie because when two percent of the tax payer population who are business successes already pay approximately half of all income taxes in the United States of America are pitted against 98 percent of the remaining population, where is the balance? Moreover, approximately 47 percent of Americans are exempt from paying income taxes.<sup>28</sup> Never begin a sentence with And. It is childish!

13. "Would you rather reduce deficits and interest rates by raising revenue from those who are not now paying their fair share, or would you rather accept larger budget

deficits, higher interest rates, and higher unemployment? And I think I know your answer. ”

CLARIFICATION/COMMENT: The quotation is direct from Ronald Reagan.<sup>29</sup> However, it is taken out of context and therefore LIE 29 because Barack Hussein Obama cannot argue that the rich are not paying their fair share of federal income taxes when we know (See above!) that at least 47 percent of Americans are exempt from paying their income tax?<sup>30</sup> Never begin a sentence with And. It is childish!

14. Those words were spoken by Ronald Reagan. But today, many Republicans in the House refuse to consider this kind of balanced approach — an approach that was pursued not only by President Reagan, but by the first President Bush, by President Clinton, by myself, and by many Democrats and Republicans in the United States Senate. So we're left with a stalemate. LIE 30

CLARIFICATION/COMMENT: In 1982, President Ronald Reagan agreed to the Tax Equity and Fiscal Responsibility Act because the arrangement with the Democrats in Congress at that time had as its goal three dollars in spending cuts for every dollar of additional tax revenue. The intent of the Tax Equity and Fiscal Responsibility Act was not to raise the marginal income tax, which Barack Hussein Obama wants to do with a five percent rate increase. The Tax Equity and Fiscal Responsibility Act deleted tax loopholes and at the same time bettered the mechanisms of tax collection. The Democrats in the Congress reneged on their promise to President Reagan to institute the spending cuts.<sup>31</sup>

15. Now, what makes today's stalemate so dangerous is that it has been tied to something known as the debt ceiling — a term that most people outside of Washington have probably never heard of before. LIE 31

CLARIFICATION/COMMENT: LIE 31 is a lie because according to two Gallup polls conducted between 5-8 May and 7-10 July 2011, approximately 65 percent of Americans know what the debt ceiling is.<sup>32</sup>

16. Understand — raising the debt ceiling does not allow Congress to spend. LIE 32 It simply gives our country the ability to pay the bills that Congress has already racked up. LIE 33 In the past, raising the debt ceiling was routine. Since the 1950s, Congress has always passed it, and every President has signed it. President Reagan did it 18 times. George W. Bush did it seven times. And we have to do it by next Tuesday, August 2nd, or else we won't be able to pay all of our bills. LIE 34

CLARIFICATION/COMMENT: Barack Hussein Obama opposed President George W. Bush's raising of the debt ceiling when he was a *voting-present* member of the Senate. In 2006, Barack Hussein Obama said, "The fact that we are here today to debate raising America's debt limit is a sign of leadership failure. ... Washington is shifting the burden of bad choices today onto the backs of our children and grandchildren. America has a debt problem and a failure of leadership. Americans deserve better."<sup>33</sup> What Americans voted for after President George W. Bush is the worst of the worst!

LIE 32 is a lie because raising the debt ceiling does allow Congress to spend more money than it has. If the debt ceiling is not raised, Congress will have to begin cutting spending that is not necessary.

LIE 33 is a lie because debt that has "already been racked up" in the past must be paid. It cannot be written off the books!

LIE 34 is a lie because there is some future spending that is not necessary. For example, the spending to implement ObamaCare is not necessary because ObamaCare is not necessary and it is unconstitutional. There are no legal obligations for the federal government to continue with the Department of Education. It and other departments and sub-departments could be eliminated.

17. Unfortunately, for the past several weeks, Republican House members have essentially said that the only way they'll vote to prevent America's first-ever default is if the rest of us agree to their deep, spending cuts-only approach. LIE 35 and LIE 36

CLARIFICATION/COMMENT: LIE 35 is a lie because the Republicans do not want a "cuts-only approach." They want to cut spending, to cap spending, and to have a balanced budget amendment to the Constitution.<sup>34</sup>

LIE 36 is a hidden lie because if a cuts-only approach was made into law, there would be no default. The hidden meaning behind Barack Hussein Obama's statement is that he will refuse this approach and that there will be a default.

18. If that happens, and we default, we would not have enough money to pay all of our bills — bills that include monthly Social Security checks, veterans' benefits, and the government contracts we've signed with thousands of businesses. LIE 37

CLARIFICATION/COMMENT: LIE 37 is a LIE because there is enough money in the treasury to pay for Social Security due to the fact that "the IOUs in the Social Security trust fund are *already included* in the national debt. If the Social Security system needs to cash in some of those IOUs, the Treasury Department can simply sell more bonds to replace them—*without* increasing the total amount of U.S. debt or exceeding the debt limit.<sup>35</sup> The same is true for there not being a default on veterans' benefit and military and federal employee salaries. Barack Hussein Obama "wants to make Americans believe that if the problem is not solved by August 2, Social Security checks and military

If an agreement is not reached, there would not be enough money to pay all the debts, but the putative president would have the authority to choose which debts to pay now and which ones to pay later."<sup>36</sup>

19. For the first time in history, our country's AAA credit rating would be downgraded, leaving investors around the world to wonder whether the United States is still a good bet. LIE 38 Interest rates would skyrocket on credit cards, on mortgages and on car loans, which amounts to a huge tax hike on the American people. We would risk sparking a deep economic crisis — this one caused almost entirely by Washington. LIE 39

CLARIFICATION/COMMENT: LIE 38 is a lie because the rating agencies would be most likely to downgrade America's AAA credit rating if the debt ceiling is raised due to the fact that they would have no trust in the United States government being able to pay off more debt and the rating agencies would not believe that the government would institute spending cuts.<sup>37</sup>

LIE 39 is a lie because Barack Hussein Obama allowed the debt crisis to escalate. He did nothing to stop it. On the contrary, last December (2010) ... he ignored his own debt commission's recommendations." In "February (2011) ... he presented a budget that increases debt by \$10 trillion over the next decade." In "April (2011) he sought a debt-ceiling increase with zero debt reduction attached."<sup>38</sup>

20. So defaulting on our obligations is a reckless and irresponsible outcome to this debate. And Republican leaders say that they agree we must avoid default. But the

new approach that Speaker Boehner unveiled today, which would temporarily extend the debt ceiling in exchange for spending cuts, would force us to once again face the threat of default just six months from now. In other words, it doesn't solve the problem. **LIE 40**

**CLARIFICATION/COMMENT:** LIE 40 is a lie because it *so/ves* the problem for six months. Barack Hussein Obama's approach of wanting a 2.7 trillion dollar raise on the debt ceiling would cause the United States of America to go bankrupt *ad infinitum*.<sup>39</sup> The Democrats would like to see the United States of America go bankrupt anyway!<sup>40</sup>

21. First of all, a six-month extension of the debt ceiling might not be enough to avoid a credit downgrade and the higher interest rates that all Americans would have to pay as a result. We know what we have to do to reduce our deficits; there's no point in putting the economy at risk by kicking the can further down the road. **LIE 41**

**CLARIFICATION/COMMENT:** The first statement is a misleading statement because a six-month expansion just as well could be enough to avoid a credit downgrade based upon the deficit ceiling, but not based on the trust of the United States of America after these six months to pay its debts. LIE 41 is a lie because of the false logic. Having a six-month-debt-ceiling-hike extension as the Republicans propose is "kicking the can down the road" but an approximate 2.7 trillion-dollar-eighteen-month-debt-ceiling-hike extension is not "kicking the can down the road"? Barack Hussein Obama is a dangerous idiot!

22. But there's an even greater danger to this approach. Based on what we've seen these past few weeks, we know what to expect six months from now. The House of Representatives will once again refuse to prevent default unless the rest of us accept their cuts-only approach. Again, they will refuse to ask the wealthiest Americans to give up their tax cuts or deductions. Again, they will demand harsh cuts to programs like Medicare. And once again, the economy will be held captive unless they get their way.

CLARIFICATION/COMMENT: These statements are mere scare tactics and the *false choice technique* in argumentation. It is a typical communist, socialist, dictatorial technique. See number 10.

23. This is no way to run the greatest country on Earth. It's a dangerous game that we've never played before, **LIE 42** and we can't afford to play it now. Not when the jobs and livelihoods of so many families are at stake. We can't allow the American people to become collateral damage to Washington's political warfare.

CLARIFICATION/COMMENT: The United States of America is no longer the "greatest country on earth" under the non-leadership of Barack Hussein Obama. The United States of America is not its government. It is "still a good country, but the people have lost their identity and have traded it with amnesty for countless millions to incorporate their culture into what used to be (indigenous American) identity."<sup>41</sup> "In the end America is not THE greatest country in the world, though she does have some extremely admirable qualities -- in some senses she is definitely the "joint-best" country in the world."<sup>42</sup>

LIE 42 is a lie because the Democrats have played the game before. For example, American voters elected "Franklin D. Roosevelt, who promised to balance the budget—and then proceeded to break virtually all of his campaign promises and steer the United States onto the road to socialism."<sup>43</sup> Furthermore, "FDR *doubled* federal spending between 1933 and 1940, hardly the actions of a fiscal conservative. Although his 1937 budget was slightly less than his 1936 budget, it was still 18 percent higher than his 1935 budget. His 1938 budget was 48.8 percent higher than his 1933 budget. FDR's 1939 budget was 33.6 percent greater than his 1938 budget—and the unemployment rate remained above 15 percent, despite the added 'stimulus.'<sup>44</sup> The last two sentences

are misleading statements because they have the intent to foresee that many Americans will lose their jobs and families will lose their livelihoods without saying that Barack Hussein Obama's economic policies have already resulted in approximately 10 percent unemployment. LIE 44

CLARIFICATION/COMMENT: LIE 43 is a lie because Barack Hussein Obama wants a blank check legislative bill that will allow him to spend as much as he wants. Barack Hussein Obama is the one who, out of political purposes, threatens to veto any legislative bill that does not extend into 2013, after the presidential election in 2012.<sup>45</sup>

LIE 44 is a lie because politicians, good ones and bad ones, never put politics aside. Doing so would be a negation of their chosen profession.

26. Now, I realize that a lot of the new members of Congress and I don't see eye-to-eye on many issues. But we were each elected by some of the same Americans for some of the same reasons. Yes, many want government to start living within its means. And many are fed up with a system in which the deck seems stacked against middle-class Americans in favor of the wealthiest few. **LIE 45** But do you know what people are fed up with most of all?

**CLARIFICATION/COMMENT:** LIE 45 is a lie because if only 2 percent of the wealthiest Americans pay up to 50 percent of the taxes, then the deck (of who pays taxes) is not stacked against middle-class Americans.

27. They're fed up with a town where compromise has become a dirty word. **LIE 46** They work all day long, many of them scraping by, just to put food on the table. And when these Americans come home at night, bone-tired, and turn on the news, all they see is the same partisan three-ring circus here in Washington. They see leaders who can't seem to come together and do what it takes to make life just a little bit better for ordinary Americans. They're offended by that. And they should be.

**CLARIFICATION/COMMENT:** LIE 46 is a lie because Americans are not fed up with a town where compromise has become a dirty word. They are fed up with Barack Hussein Obama! "A *Washington Post-ABC News* poll released Tuesday (June 7, 2011) says 59 percent — six in ten Americans — disapprove of the way the President is handling the economy and only 33 percent approve of his handling of the deficit."<sup>46</sup>

28. The American people may have voted for divided government, but they didn't vote for a dysfunctional government. **LIE 47** So I'm asking you all to make your voice heard. If you want a balanced approach to reducing the deficit, let your member of Congress know. If you believe we can solve this problem through compromise, send that message.

Only those graduates of leftist high schools and colleges and universities have been dumbed down to believe that the governmental system of the United States of America is a democracy.

LIE 49 is a lie because the United States of America is not made up of every race and religion present in the world. The United States of America is made up of 50 separate, federal, constitutional republics known as states.

LIE 50 is a lie because not all beliefs and points of view are welcomed. The United States of America does not welcome socialism, communism, or dictatorial regimes. The United States of America does not welcome fascism. The United States of America does not welcome anti-Semitism, although Barack Hussein Obama is doing his best to make anti-Semitism acceptable. "Lying and cheating in the Arab world is not really a moral matter but a method of safeguarding honor and status, avoiding shame, and at all times exploiting possibilities, for those with the wits for it, deftly and expeditiously to convert shame into honor on their own account and vice versa for their opponents. If honor so demands, lies and cheating may become absolute imperatives."<sup>51</sup>

"No dishonor attaches to such primary transactions as selling short weight, deceiving anyone about quality, quantity or kind of goods, cheating at gambling, and bearing false witness. The doer of these things is merely quicker off the mark than the next fellow; owing him nothing, he is not to be blamed for taking what he can."<sup>52</sup>

The two quotations above are the exact description of Barack Hussein Obama's immoral character. For Muslims, *al-Taqiyya* is the Islamic principle of lying for the sake of Allah. For Barack Hussein Obama it is the principle of lying for the sake of Barack Hussein Obama.
