Throw Shoes At Barack Hussein Obama!

A Call To Take Action Number Fifteen



There is no historically documented record of when throwing a shoe or shoes at someone was used as a form of political criticism. In many cultures the shoe and the foot have a special symbolical meaning. When one walks barefoot, the soles of the feet get dirty. When wearing shoes, the shoes get dirty and the feet can become smelly. Although there is no mention in the Koran or the Hadith of Muhammad that throwing shoes at someone is condoned, throwing a shoe at someone is a behavior common in Islamic countries. Therefore, it is not prohibited. It is allowed. To throw a shoe or shoes at someone as a target indicates that the targeted person is no better than dirt! Since the arrival of Barack Hussein Obama from hell in 2008/2009 and the reappearance in 2012/2013 at Washington, D. C., scandal news that has not been covered by the enemedia has circulated throughout the United States of America. These revelations have brought to the fore a great variety of speculation concerning Barack Hussein Obama's criminal involvement in at least 26 scandals, which are herewith listed chronologically. Detailed information concerning the contents of the scandals will be found in various non-enemedia reports and publications.

- January 19, 2009 Barack Hussein Obama takes oath of office: On January 19, 2009, Barack Hussein Obama took his oath of office to uphold the laws of the *Constitution for the United States of America* after the fact that he knowingly broke the law of the natural born citizen clause (Article 2.1.5) of the *Constitution*.
- 2. **February 15, 2009 David Axelrod's AKPD Message and Media:** The Obama regime \$2 million to the firm of former-White House adviser David Axelrod in order to promote the passage of Obamacare. Evidence exists that the money was used to pay David Axelrod \$2 million that AKPD owed him. In other words, indications are that the Obama regime paid off a private debt of a non-government organization to David Axelrod.
- 3. June 6, 2009 Inspector General Gerald Walpin fired: Inspector General Gerald Walpin of the Corporation for National and Community Service was fired in 2009. He fought wasteful spending and investigated a friend of Obama's, Sacramento Mayor and former NBA player Kevin Johnson. The White House says Walpin was incompetent. Walpin says Kevin Johnson is a criminal. There are indications that Michelle Obama instigated Walpin's firing.
- 4. February 2010 Sestak (D-PA)-Specter (D-PA): At the request of former White House Chief of Staff Rahm Emanuel, former President Bill Clinton acted as an intermediary to find out whether or not former Representative Joe Sestak (D-Pa.) would accept a prominent, unpaid White House advisory position in exchange for dropping out of the 2010 primary against former Sen. Arlen Specter (D-PA.). Sestak lost the senatorial election to Republican Pat Toomey.
- 5. **February 2010 Fast and Furious gun running scheme:** The Justice Department's Office of Alcohol, Tobacco, Firearms and Explosives allowed weapons-trafficking from the United States into Mexico. The agency lost track of the firearms. Many of them landed in the hands of Mexican drug cartel dealers. They used the firearms to kill their opponents. One of the

- firearms was used in the killing of United States Border Patrol Agent Brian Terry on December 14, 2010.
- 6. Beginning in March 2010 Internal Revenue Service targets Obama's enemies: In the time period leading up to the 2012 election, conservative and pro-Israel groups seeking tax-exempt status were targeted and denied tax-exempt status.
- 7. July 2010 The New Black Panthers Racial Double Standard: The United States Department of Justice under Attorney General Eric Holder used a racial double standard and did not pursue a voter intimidation case against the Black Panthers who menaced voters at a polling place in Philadelphia in November 2008.
- 8. October 2010 General Services Administration: In October 2010, the General Services Administration held a training conference in Las Vegas that cost \$823,000. A clown (not Obama) and a mind reader (not Valerie Jarrett) were part of the training show. The head of the GSA, Martha Johnson, Robert Peck, the chief of the Public Buildings Service, which is part of the agency, and Ms. Johnson's top adviser, Stephen Leeds had to resign their positions. Some minor officials were placed on forced leave.
- 9. March 19, 2011 Obama wages war without Congressional approval:
 Obama violated the *Constitution* as well as the War Powers Resolution
 (1973) by attacking Libya without the approval of Congress. The same can be argued for Obama's support of terrorists in Syria (October 2012).
- 10. May 2011 Perjury by Attorney General Eric Holder, Case I: The evidence is that Eric Holder knew about the gun running scheme Fast and Furious before he told Congress in May 2011 that he had not before heard about the Fast and Furious scheme.
- 11. July-August 2011 Veterans Affairs Conferences in Disney World: The Veterans Administration agency wasted more than \$6 million with unauthorized expenditures on two conferences in Orlando, Florida.

- 12. August 31, 2011 Solyndra: The Obama regime funded and promoted its pet green energy company despite warning signs that Solyndra would go into bankruptcy. The Obama regime pressed Solyndra to delay the specific announcements of its layoffs and bankruptcy until after the 2010 midterm congressional elections.
- 13. **February 25, 2012 Kathleen Sebelius violates the Hatch Act:** Kathleen Sebelius made "extemporaneous partisan remarks" during an official speech on February 25, 2012. She called for the election of the DemocRAT candidate for governor of North Carolina. This was a violation of the Hatch Act, which prohibits employees of the executive branch from participation in partisan politics.
- 14. May 2012 Sussing Out the Associated Press: As part of a leak investigation The United States Department of Justice under Attorney General Eric Holder performed a massive investigation of Associated Press reporters' telephone records.
- 15. September 11, 2012 Benghazi: On the eve of September 11, 2012, Islamic terrorists attacked the United States diplomatic mission in Benghazi, Libya. The result of the attack was the killing of Ambassador J. Christopher Stevens and United States Foreign Service Information Management Officer Sean Smith, as well as two CIA contractors Tyrone S. Woods and Glen Doherty. Ten others were wounded in the Islamic terrorist attack. The Benghazi scandal is really three-scandals-in-one scandal: 1.) official government talking points insinuated that the reason for the Benghazi terrorist attack was an anti-Muslim video; 2.) the Benghazi mission was not protected despite repeated demands by Ambassador Stevens for protection and security; 3.) members of the Obama regime refuse to say where Barack Hussein Obama was the night of the Benghazi terrorist attack.
- 16. September 2012 Anthony Rodman, Hillary Clinton's brother, obtains illegal visas: Alejandro Mayorkas, Director of the U.S. Citizenship and Immigration Services, is being investigated because he may have used his

- position to illegally obtain U.S. visas for foreign investors in Anthony Rodman's company Gulf Coast Funds Management.
- 17. November 7, 2012 Political Prisoner Nakoula Basseley Nakoula: "We're going to go out and we're going to prosecute the person that (sic: who) made that video," Hillary Clinton allegedly told the father of one of the ex-SEALs killed in Benghazi. Thereupon the writer, producer, and promoter of the anti-Muslim video *Innocence of Muslims* was arrested and sentenced to prison. Mr. Nakoula was used as a scapegoat for the Obama regime's Benghazi crimes.
- 18. March 2013 Vice-President Joe Biden bullies the press: Vice-President Biden's office has repeatedly and actively interfered with news coverage of Joe Biden. They forced a reporter to wait in a closet. They made a University of Maryland student reporter delete photos, and they edited pool news reports.
- 19. March 2013 The Pigford Payment scandal: In 2013, the United States Department of Agriculture attempted to compensate black farmers who had been discriminated against by the Department of Agriculture. The agency gave several billion dollars in cash to thousands of minority and female farmers who were not discriminated against by the Department of Agriculture.
- 20. **May 2013 Rosengate:** The United States Department of Justice claimed that reporter James Rosen (Fox News) committed a crime because he reported about classified information. The Justice Department illegally monitored his phones and emails.
- 21. May 2013 Perjury by Attorney General Eric Holder, Case II: Eric Holder told Congress he had never been associated with "potential prosecution" of any journalist. The fact is that he signed the document that designated James Rosen, a Fox News reporter, as a potential criminal.
- 22. May 2013 Kathleen Sebelius demands payment: In May 2013, Secretary of Health and Human Services Kathleen Sebelius intentionally

- solicited donations from companies that she in her official position of Secretary would possibly regulate. This was payment money to help sign up uninsured Americans for ObamaCare, which is against the law.
- 23. **June 2, 2013 Lisa Jackson is Richard Windsor:** The former Environmental Protection Agency Administrator Lisa Jackson used the pseudonym *Richard Windsor* in email correspondence with other government officials. This was an attempt to evade scrutiny, transparency, and congressional control.
- 24. August 7, 2013 CBS Reporter Sharyl Attkinson's computer hacked: CBS reporter Sharyl Attkinson had her computer hacked during her investigation of the Benghazi scandal. Evidence and indications are that the hacking came from the Obama regime because they are the only hackers who have the capability of such complete hacking.
- 25. **These are my laws:** Dictator Barack Hussein Obama has repeatedly decided which laws to enforce and which laws not to enforce. Two prime examples are: 1.) his continuing personal goal since he was a United States Senator and his decision since he has been the illegal occupier of the Oval Office not to deport illegal immigrants; 2.) his personal changes to regulations in the ObamaCare (Affordable Care Act) legislation. Since April 19, 2011 Obama has made 40 changes to the Affordable Care Act without congressional approval.
- 26. The Veterans Administration: Various Veteran Administration hospitals in Arizona, Colorado, Wyoming, Illinois, North Carolina, Florida, Mississippi, New Mexico, and Texas falsified secret lists of appointment data in order to conceal the fact that veterans had long waiting times and were being denied proper and prompt medical care. Obama does not call for the resignation of the Secretary of Veterans Affairs, four-star General Eric Ken Schinseki, but praises him instead.

These alone are justification enough for Americans to throw shoes at Barack Hussein Obama! The speculation of Barack Hussein Obama's criminality in these scandals has not been a subject of the enemedia, but a never-ending matter for American Patriots. In addition to the above scandals, Senator Ted Cruz (R-Texas) has thoroughly documented instances in which Barack Hussein has willingly broken the laws of the United States of America. The series of reports began in April 213. They are:

- A. **The Legal Limit Report No. 1:** U.S. Supreme Court Rejects Department of Justice's Expansive View of Federal Power. Nine times the Supreme Court of the United States rejected the Obama regime's positions on the expansion of federal power.
- B. **The Legal Limit Report No. 2:** The Obama Administration's Lawless Acts on Obamacare and Continued Court Challenges. The Obama regime has repeatedly ignored the law of ObamaCare and has changed the text of the law 40 times without the approval of Congress.
- C. **The Legal Limit Report No. 3:** The Obama Administration's Assault on Texas. The State of Texas has filed multiple lawsuits to prevent the Obama regime from assuming powers reserved for the individual states.
- D. **The Legal Limit Report No. 4:** The Obama Administration's Abuse of Power. This is a listing of attempts by the Obama regime to take control of executive nominees, free speech, national security, ObamaCare, privacy, the economy, etc.

These scandals and the documented reports of Barack Hussein Obama breaking the law are proof that more than just any *fauxpas* is at play in the enemy-Obama-thug regime. They are always under the water and it is certain that they have run their length of madness. That the thug regime is under the necessity of changing their measures may easily be seen into; but to what their change of measures may amount, or how far they may correspond with American interest, happiness, and duty, is yet uncertain; and from what Americans have hitherto experienced, WE the People have too much reason to suspect them in everything.

I address this writing so much to the brain-dead POLDS – the Progressives, Obots, Leftists, Dumbed-downers, Socialist-communists – for if it is their intention to promote any kind of good words for Barack Hussein Obama, it is proper they should know beforehand that the United States of America have as much honor as bravery; and that WE the People are no more to be seduced from OUR Patriotism alliance than that their allegiance to Obama is correct behavior. The American Patriots' line of politics is formed and not dependent, like that of OUR enemy, on chance and accident.

On OUR part, in order to know at any time what the Obama regime will do, WE have only to find out what they ought not to do, and this last will be their conduct. Forever changing and forever wrong; too distantly removed from patriotic, grass-roots America to improve in circumstances, and too unwise to foresee them; scheming without principle, and executing without probability; their whole line of management has hitherto been blunder and baseness. Every policy has added to their loss, and every year to their disgrace, till unable to go on, and ashamed to go back, their hope-and-change politics have come to a halt, and all their fine prospects to a halter. Barack Hussein Obama as failure-in-chief has prostrated himself to himself.

Could OUR affections forgive, or humanity forget the wounds of an injured country, WE the People might, under the influence of a momentary oblivion, stand still and laugh. But the Obama regime is engraven where no amusement can conceal them, and is of a kind for which there is no recompense. Can the Obama regime restore to America the beloved dead? Can the Obama regime say to the grave, give up the murdered? Can the Obama regime obliterate from Americans' memories those who are no more? Barack Hussein Obama! Think not then to tamper with America's feelings by an insidious contrivance, nor suffocate American humanity by seducing US to dishonor!

There has appeared some disposition in the Obama thug regime to cease the further prosecution of the domestic war. However, it would be accompanied by a dishonorable proposition to American citizens. By the speeches and statements which have appeared from the White House, it is easy to perceive to what impolitic and imprudent excesses the Obama regime's passions and

prejudices have, in every instance, carried them during the domestic war. Provoked at the upright and honorable actions of American Patriots, the Obama regime imagined that nothing more was necessary to be done to prevent the final subjection than to promise, through the agency of their enemedia, a repeal of their offensive acts of bullying WE the People. The vanity of the conceit is as unpardonable as the experiment is impolitic.

I am so convinced of the wrong ideas of the Obama regime that I shall not wonder, if in their last stage of political frenzy, they propose to WE the People to accept Obama's socialism-communism as a sign of enduring reverence for The One. Such a proposition, should it ever be made (It has already been more than once hinted at in the regime and by the enemedia) would discover such a disposition to perfidiousness, and such disregard of honor and morals, as would add the finishing vice to Obama's national corruption. I do not mention this to put America on the watch, but to put Barack Hussein Obama and his minions on their guard that they do not, in the looseness of their non-present hearts, envelop in disgrace every fragment of what remaining reputation they might possess.

By the complexion of some part of the news which has transpired through the enemedia, it seems probable that this insidious era in the Obama regime's politics is beginning to make its appearance. I wish it may not; for that which is a disgrace to human nature throws something of a shade over all the human character, and each individual feels his share of the wound that is given to the whole.

The policy of the Obama regime has ever been to divide America in some way or other. In the beginning of the dispute, Obama practised every art to prevent or destroy the union of America, well knowing that could he once get them to stand singly, he could conquer them unconditionally. But this is not all. He will uninterruptedly pour out all his regime's force and fury upon America, for it is evident that Barack Hussein Obama is to draw America from world-wide importance.

Failing domestically, Obama has placed his perspective on international relations and has apparently made concessions to Russia, China, Iran, and even North Korea in foreign policy, mainly by not taking any action against their power maneuvers. What is still more extraordinary, he at the same time made propositions to Islamic countries providing insurgents in Syria to further draw America into that conflict. Worry not American Patriots, for Barack Hussein Obama will be disappointed in the actions of his plans.

It is a thing very extraordinary and even ridiculous that the Obama regime which superficially says that America is independent, not only in acting, but of right, during the domestic war, should now have a repugnance to treat America as not being qualified to participate independently in individual rebellion.

WE the People answer that the Obama regime in the terms already mentioned are insulting themselves without knowing it. The Obama regime is making very great offers to American adversaries with the intent of submitting to their terms of politics. But there is yet more. Barack Hussein Obama is ruining the economic wealth of America by plunging the country into more debt, all the more to accommodate matters and interests with socialist-communist theory.

From what has been observed, it evidently follows that the whole of the Obama regime politics is to disunite America by means of the false promises and offers which he separately made and still makes to the various politicians of the DemocRAT Party; and also to separate the states from consultations with each other and induce federal bureaucracies to arm against WE the People, or more probably to oppress US when they find US and OUR patriotic engagement so that WE might stand alone and without protection. Yet, dictator Obama and his regime forget that American Patriots can protect themselves and America.

This, therefore, is the net Barack Hussein Obama has laid for WE the People; that is to say, to tempt US with flattering and very magnificent promises to come to an accommodation with his regime, exclusive of any intervention of American Patriots, conservative personalities, or organizations.

The Muslim king of the Oval Office in Washington, D. C. will make all the efforts in his power to obtain a solid and permanent peace according to wishes of world Islam, with full and satisfactory securities that America will accord to Islamic sharia law. Barack Hussein Obama is faithful on the one part of the engagements which bind him to his Muslim belief; unjust and anti-upright on the other to his own subjects whom he ought to protect and guard against so many dangers. Full of humanity and compassion for other nations except republics, he is determined to pursue and prosecute American success as well as individual Americans who according to him suffer under the free-market economic system.

What I have here given serve to show the various endeavors and contrivances of the enemy Obama regime to draw Americans from their connections with conservative, market-oriented America, and to prevail on Americans to make a separate accommodation with socialism-communism, leaving America totally out of the question, and at the mercy of a merciless, unprincipled, unethical and evil socialist-communist-Muslim enemy. Likewise, the opinion that has been formed by WE the People that Barack Hussein Obama's character for meanness and perfidiousness is becoming more exactly the opinion of America. The criticism eventually contains American Patriots' statements and language; for Americans, however remote, who think alike, will unavoidably speak alike. WE see the insidious use which Barack Hussein Obama has endeavored to make of the propositions facing America under socialism-communism in the framework of the Islamic world unity, the umma.

I could wish the enemedia at liberty to make use of all the information which I am sure they possess or have access to on Mr. Fraud, Barack Hussein Obama, but as there is a delicacy in the matter, the enemedia do not conceive it prudent, at least at present, to make references and quotations in the same manner as I have done with respect to Barack Hussein Obama. Those in the enemedia fear for their lives, the lives of their families, and the loss of their positions. Therefore, what comes from me on this part of the business, must rest on my own credit with the public, assuring them that when the whole proceedings relative to the exposure of all aspects of Barack Hussein Obama's

life shall appear, they will find my account and the in-depth accounts of my colleagues in Patriotism not only true, but studiously important for the future concerning the greatest fraud in history.

WE know at this time that the expectation of the usurped Oval Office and the thug regime ran high with respect to the conquest of America. Filled with these high ideas, nothing could be more insolent towards America than the language and lies spewing forth from Obama in his blasts of verbal diarrhea. America is to be left to Obama's mercy, if she does not heed the writing on the wall of future history.

On the other hand, American Patriots with open, noble, manly determination, and a fidelity of good, patriotic brother-and-sister allies, will hear no proposition for a future pardoning of Barack Hussein Obama's treason against America. We insist that the presidential eligibility clause of the *Constitution* should be fully and unequivocally pounded into the brain-dead POLDS again and again in the style of American patriotic language.

Since the initial days of the Obama regime beginning in 2009, a reverse of fortune has overtaken pro-Obama political thoughts in Washington, D. C. and all the high expectations of the Obama regime are now crashing to the ground. Political opponents have read the Obama regime a loud lesson of disgraceful misfortune and necessity has called on the Obama regime to change their ground, for they are now criticizing the economic programs they themselves initiated.

In this situation of confusion and despair the present Obama regime politics have no fixed character. It is now the hurricane months of lame-duck politics. Every day seems to have a storm of its own, and they are scudding under the bared poles of hope and change. Beaten, but not humble; condemned, but not penitent, the POLDS act like men and women trembling at fate and catching at a straw. From this convulsion, in the entrails of their politics, it is more than probable that the mountain groaning in labor will bring forth a mouse as to its size, and a monster in its make. They will try on America the same insidious

arts socialists-communists have always tried in every country they have attempted to conquer.

WE the People sometimes experience sensations to which language is not equal. The conception is too bulky to be born alive and in the torture of thinking WE stand dumbfounded. OUR patriotic feelings, imprisoned by their magnitude, find no way out. In the struggle of expression every finger and both hands try to be a tongue. The machinery of the body seems too little for the mind and WE look about for help to show OUR thoughts. Such must be the sensation of America whenever Barack Hussein Obama, teeming with corruption, shall propose to Americans that they sacrifice their faith in Christianity, traditions, ethics, and constitutional law.

Exclusive of the wickedness there is a personal offence contained in every such attempt. It is calling American Patriots villains: for no man asks the other to act the villain unless he believes him inclined to be one. No man attempts to seduce the truly honest woman. They argue it is the supposed looseness of her mind that starts the thoughts of seduction, and he who offers it calls her a prostitute. OUR pride is always hurt by the same propositions which offend our principles; for when WE are shocked at the crime, WE are wounded by the suspicion of OUR compliance.

Could I convey a thought that might serve to regulate the public mind, I would make the interests of the Founding Fathers the basis of defending America. All the world is moved by interest, and it affords them nothing to boast of. But I would go a step further and defend America on the ground of honor and principle. That America's public affairs have flourished under the guidance of the Founding Fathers; that it was wisely made and has been nobly executed; that by their principles and foresight WE are enabled to preserve OUR country from conquest, and expel those who seek OUR destruction; that it is OUR true interest to maintain it unimpaired; and that while WE do so no enemy can conquer US, are matters which experience has taught US, and the common good of OURSELVES, abstracted from principles of faith and honor, would lead US to maintain the connection to the Founding Fathers

Over and above the mere letter of the Founding Fathers' logic, WE have been nobly and generously treated, and have had the same respect and attention paid to US, as if WE had been an old established country. To oblige and be obliged is fair work among humankind, and WE want an opportunity of showing to the world that WE are a people sensible of kindness and worthy of confidence without Barack Hussein Obama. Character is to US, in our present circumstances, of more importance than interest. The United States of America is a young nation upon the stage of public life, and the eye of the world is upon US to see how WE act with the elected, cowardly, criminal Barack Hussein Obama. WE have an enemy who is watching to destroy OUR reputation, and who will go to any length to gain some evidence against US that may serve to render OUR conduct suspect and OUR character odious. Could the Obama regime accomplish this, wicked as it is, the world would withdraw from America, as from a people not to be trusted, and America's task of being a bulwark of freedom would then become difficult. The present example is the hatred the Egyptian people have for Barack Hussein Obama and his regime for their support of the former President of Egypt: Mohammed Morsi and his Muslim Brotherhood.

There is nothing which sets the character of a nation in a higher or lower light with others than the faithfully fulfilling their oaths of office, or perfidiously breaking their oaths of office. Oaths of office are not to be tampered with. Should Barack Hussein Obama, which seems very probable, propose that oath-taking for public office be done away with, it would merit from American patriotism a mark of detestation. It is one of those extraordinary instances in which WE ought not to be contented with the bare negativeness of Congress, because it is an affront on the multitude as well as on the government. It goes on the supposition that the public are not honest men and women, and that they may be managed by contrivance, though they cannot be conquered by arms. Let the world and Barack Hussein Obama know that WE American Patriots are neither to be bought nor sold; that OUR mind is great and fixed; OUR prospect clear; and that WE will support OUR character as firmly as OUR independence.

The Obama regime supposes they have many friends in America and that when all chance of conquest is over, they will be able to support DemocRAT Party politics *ad infinitum*. Now, if I have any conception of the human heart, the Obama regime will fail in this more than in anything that they have yet tried.

This is not a question of policy only, but of honor and honesty; and the proposition will have in it something so visibly low and base that their partisans, if they have any, will be ashamed of it. Men are often hurt by a mean action who are not startled at a wicked one, and this will be such a confession of inability, such a declaration of servile thinking that the scandal of it will ruin all their hopes.

Of course, it is not practical to throw shoes at Barack Hussein Obama whenever he appears in public. Yet, there is one resort that Patriotic Americans have in this regard. WE can erect Barack Hussein Obama scarecrows in back yards, driveways, and fields and throw shoes at the scarecrows!

In short, WE the People, American Patriots all, have nothing to do but to go on with vigor and determination, because the enemy is still in control of OUR country.
